### Notification of Proposed Annexation by the City of San Marcos – AN-24-07 (Old Bastrop & McCarty Mixed Use)

Dear Public Entity Representative:

Under Local Government Code Chapter 43, cities are required to notify certain public entities of all proposed annexations. The San Marcos City Council is considering the following annexations that may affect your jurisdiction:

Annexation of 51 +/- acres of land, more or less, out of the Cyrus Wickson Survey, Abstract No. 474, generally located on the southern side of FM-110/ East McCarty Lane and the northern side of Old Bastrop Highway, approximately 1,600 ft. west of the intersection between Old Bastrop Highway and SH-123 in Hays County, Texas.


