



## **Service Plan for the Annexation of 5.42 +/- Acres of County Right-of-Way**

Pursuant to the provisions of the Texas Local Government Code, Chapter 43, the following service plan is hereby adopted for the annexation of 5.42 +/- acres of County right-of-way. The property is being annexed at the request of the City of San Marcos and Hays County.

The proposed annexation area is located within the following limits and further described in Exhibit A:

1. Centerpoint Road adjacent to the annexation under Ordinance 1994-50
2. S. Old Bastrop Highway from the annexation under Ordinance 2024-49 to the annexation under Ordinance 2004-77
3. Clovis Barker Road adjacent to UMC Subdivision, from the annexation under Ordinance 2015-29 to the annexation under Ordinance 1998-71
4. Yarrington Road adjacent to the Whisper East annexation under Ordinance 2022-47
5. Transportation Way and ½ of Lembo Drive adjacent to the annexation under Ordinance 2022-33
6. Transportation Way adjacent to the annexation under Ordinance 2020-32

### **1. Police Protection**

Police services, including patrolling, response to calls and other routine services, will begin on the effective date of the annexation using existing personnel and equipment.

### **2. Fire Protection**

Fire protection services, including emergency response calls, will begin on the effective date of the annexation using existing personnel and equipment and within the limitations of the available water supply.

### **3. Emergency Medical Services**

The City of San Marcos contracts for emergency medical services through the San Marcos – Hays County EMS, which already provides service to the area being annexed.

### **4. Operation and Maintenance of Roads and Streets**

The City of San Marcos will be responsible for operation and maintenance of the right-of-way following annexation.

**S. Old Bastrop Highway from the annexation under Ord. 2024-49 to the annexation under Ord. 2004-77**





**Clovis Barker Road from the annexation under Ord. 2015-29 to the annexation under Ord. 1998-71**






