LEGAL DESCRIPTION

DESCRIPTION OF 4.532 OF ACRES (197,395 SQ. FT.) OF LAND, SITUATED IN THE J. VERAMENDI SURVEY ABSTRACT NUMBER 17 IN THE CITY OF SAN MARCOS, HAYS COUNTY, TEXAS, AND BEING OUT OF A CERTAIN 4.596 ACRE TRACT OF LAND CONVEYED TO ARMANDO C. GARZA, OF RECORD IN VOLUME 1053, PAGE 96, OFFICIAL PUBLIC RECORDS HAYS COUNTY, TEXAS; SAID 4.532 OF ACRES (197,395 SQ. FT.) OF LAND, AS SHOWN ON THE ACCOMPANYING SKETCH, BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

COMMENCING at a 1/2-inch iron rod found on the south right-of-way line of River Road, a variable width right-of-way, at the west corner of said 4.557 acre tract, being also the north corner of a certain remainder of 57.982 acre tract of land conveyed to Ralph Crouch of record in Volume 1018, Page 75, Deed Records, Hays County, Texas;

THENCE, S 45°26'06" E, along the north line of said Crouch tract, being also the south line of said 4.557 acre tract, for a distance of 297.53 feet to a 1/2-inch iron rod found at the east corner of said Crouch tract, being also the north corner of a certain 44.32 acre tract of land conveyed to A.E. Cummings, Inc. of record in Document Number 19045751, Official Public Records, Hays County, Texas;

THENCE, S 45°38'50" E, along the north line of said Cummings tract, being also the south line of said 4.557 acre tract, at a distance of 129.98 feet passing a 25" Hackberry tree found for the south corner of said 4.557 acre tract, being also the west corner of said 4.596 acre tract, for a total distance of 161.07 feet to a 1/2-inch iron rod with cap stamped "ZWA" set, on the south line of said 4.596 acre tract being also on the north line of said 44.32 acre tract, having grid coordinates of (N=13,867,609.55, E=2,311,945.88) and being the west corner and **POINT OF BEGINNING** of the herein described tract;

THENCE, N 43°45'53" E, departing said south line of said 4.596 acre tract, and being said north line of said 44.32 acre tract, crossing said 4.596 acre tract, for a distance of 202.28 feet to a 1/2-inch iron rod with cap stamped "ZWA" set, on the west line of said 4.596 acre tract, being also the east line of said 4.557 acre tract, for an angle point on the west line of the herein described tract;

THENCE, N 52°31'03" E, continuing with said east line of said 4.557 acre tract, being also said west line of said 4.596 acre tract, at 73.01 feet passing an 1/2-inch iron rod found on said east line of said 4.557 acre tract, being also the west line of said 4.596 acre tract, for a total distance of 139.14 feet to a calculated point in the river, at the east corner of said 4.557 acre tract, being also the north corner of said 4.596 acre tract, being also on the south line of that certain 57.059 acre tract of land conveyed to Alpha 80 Associates LLC, of record in Volume 5370, Page 256, Deed Records, Hays County, Texas, and being the north corner of the herein described tract;

THENCE, departing said south line of said 57.09 acre tract, being also said north line of said 4.596 acre tract, along the north line of said 4.596 acre tract, the following four (4) courses and distances;

- 1) S 37°53'15" E, for a distance of 98.60 feet to a calculated point in the river, for an angle point on the north line of the herein described tract;
- 2) S 07°38'15" E for a distance of 147.29 feet to a calculated point in the river, for an angle point on the north line of the herein described tract;
- 3) S 55°38'15" E, for a distance of 166.54 feet to a calculated point in the river, for an angle point on the north line of the herein described tract:
- 4) S 34°15'14" E, for a distance of 365.64 feet to 1/2-inch iron rod found at the east corner of said 4.596 acre tract, and being an angle point on the south line of said 57.059 acre tract, and being the east corner of the herein described tract;

THENCE, S 32°18'24" W, with the east line of said 4.596 acre tract, and being the west line of said 57.09 acre tract, for a distance of 196.99 feet to 1/2-inch iron rod with cap stamped "ZWA" set at the south corner of said 4.596 acre tract, being also the southwest corner of said 57.059 acre tract, being on the north line of said 44.32 acre tract, and being the south corner of the herein described tract;

THENCE, N 45°38'50" W, with the south line of said 4.596 acre tract, being also said north line of said 44.32 acre tract, for a distance of 794.99 feet to the POINT OF BEGINNING and containing 4.532 acres (197,395 sq. ft.) of land.
