A. PROJECT SUMMARY

Summarize how CDBG funds are proposed to be used:

The existing sidewalks along Thorpe Lane remain non-compliant with ADA standards. This area is home to two lowincome housing complexes with a high concentration of residents with disabilities. The proposed ADA improvements are essential to enhancing accessibility and mobility for these individuals. Initial funding was approved to fund both design and construction; however, as design work progressed, field investigations revealed additional needs that require further design efforts and increased construction scope. As a result, additional funding is now being requested to address these unforeseen conditions and ensure the project area fully meets ADA requirements. The estimated cost for the additional design work is ~\$35k and anticipated to be completed September 2025. The additional construction scope is expected to cost ~\$715k and is anticipated to be completed by April 2026.

The success would be measured by all the sidewalks and driveways installed passing inspection and being ADA complaint. 575 Low-income households will be directly impacted. This sidewalk will provide an ADA compliant pathway for these residents to grocery stores and other amenities.

The sidewalk existed prior to 1995, and with the construction of newer private facilities along Thorpe Lane the sidewalk has fallen out of ADA compliance. The need for this project has increased with the number of total residents moving to the area. There are two student housing complexes that were developed in the immediate area in the last ten years. This sidewalk will provide all the residents in the area with access to Hopkins St. where many government facilities are located (City Hall, San Marcos Library, Activity Center, City Clerks Office).




