1. Consider approval of Ordinance 2023-48, on the second of two readings, annexing into the City approximately 147.846 acres of land out of the L. Glassgow Survey No. 14, Abstract No. 188 and the John Williams Survey, Abstract No's. 471 and 490 (including adjacent right-of-way), in Hays County, Texas, generally located at the southwest corner of the West Centerpoint Road and Ranch Road 12 intersection (Case No. AN-23-01); including procedural provisions; and providing an effective date;

- 2. Consider approval of Ordinance 2023-49, on the second of two readings, amending the Official Zoning Map of the City in Case ZC-23-02, by rezoning approximately 90.00 acres of land out of the L. Glassgow Survey No. 14, Abstract No. 188 and the John Williams Survey, Abstract No's. 471 and 490, in Hays County, Texas, generally located at the southwest corner of the West Centerpoint Road and Ranch Road 12 intersection, from "FD" Future Development to "CC" Community Commercial or, subject to consent of the owner, another less intense zoning district classification, including procedural provisions; and providing an effective date.
- 3. Consider approval of Ordinance 2023-50, on the second of two readings, amending the Official Zoning Map of the City in Case ZC-23-15, by rezoning approximately 57.846 acres of land out of the L. Glassgow Survey No. 14, Abstract No. 188 and the John Williams Survey, Abstract No's. 471 and 490, generally located at the southwest corner of the West Centerpoint Road and Ranch Road 12 intersection, from "FD" Future Development to "CD-1" Character District 1 or, subject to consent of the owner, another less intense zoning district classification, including procedural provisions; and providing an effective date.
- 4. Consider approval of Ordinance 2023-51, on the second of third readings, granting to Universal Natural Gas, LLC d/b/a Universal Natural Gas, Inc., the right, privilege and franchise to construct, install, extend, remove, replace, abandon, operate and maintain its facilities within the public rights-of-way of the City of San Marcos, Texas for the transportation, delivery, sale and distribution of natural gas; containing other provisions relating to the foregoing subject; providing for severability; including procedural provisions; providing for approval on three readings of the ordinance; and providing an effective date.
- 5. Consider approval of Resolution 2023-114R, approving the award of a construction contract to EVT Construction for the Blanco Vista Waterline project in the amount of \$511,505.06; authorizing the City Manager or her designee to execute the appropriate documents related to this contract on behalf of the City; and declaring an effective date.
- 6. Consider approval of Resolution 2023-115R, authorizing a Change in Service to the professional services agreement with Lockwood, Andrews & Newman, Inc. related to the Purgatory Creek Improvements Phase 1 project in the estimated amount of \$825,756.35 for supplemental engineering services; authorizing the City Manager or her designee to execute the appropriate documents to implement the Change in Service on behalf of the City and declaring an effective date.
- 7. Consider approval of Resolution 2023-116R, increasing the base salary of City Clerk, Elizabeth Trevino, by \$4,410.00, effective as of May 1, 2023; and declaring an effective date.
- 8. Consider approval of Resolution 2023-117R, increasing the base salary of Municipal Court Judge, Dallari Landry, by \$7,645.26, effective as of May 1, 2023; and declaring an effective date.

9. Consider approval of Resolution 2023-118R, increasing the base salary of City Manager, Stephanie Reyes, by \$10,000.00, effective as of May 1, 2023; amending the City Manager's Employment Agreement to provide for the City to pay the City Manager's contributions to the TMRS retirement system; authorizing the Mayor to execute this amendment on behalf of the City; and declaring an effective date.
