## **About the Project**


- Approx 74,000 SF Family Travel Center
- 120 Fueling positions with capacity for Electric Vehicle charging
- Located on ~ 22 acre site fronting Southbound I-35
- Capital investment of \$50 million
- 175 Full time jobs average annual wage \$43,855






- Any Edwards Aquifer Zone or

## **Sustainability**

#### **Stormwater Quality:**

Stormwater collection is designed to direct stormwater run-off from customer fueling and bulk delivery areas to one system, flowing to one or more oil/water separators.

#### **Water Conservation:**

- Rain-sensor irrigation system
- Rainwater harvesting system (1st for the company)
- High efficiency water fixtures and lighting



## **Sustainability Continued**

#### **Energy Conservation:**

- Integrated timed/light-sensing controls
- All exterior light fixtures are fully shielded, full cut-off, 100% downward directional, and mounted as low as practical.
- 65% of the total lumen output is situated under the fuel canopies.

#### **Electric Vehicle Charging:**

- Plan is to accommodate EV charging stations along perimeter parking
- Approximately 100-175 spaces available to install as dictated by consumer demand and third-party providers



## **Proposed Jobs**

#### Number of Proposed Full Time Jobs

- Planned Jobs = 200 to 225
- 175 minimum number of jobs needed to operate store during a pandemic
- Typical starting wage is \$18/hour with benefits

#### **Employee Benefits:**

- Employer sponsored health insurance starting after 60 days
- 401k 100% match up to 6%
- 3 weeks paid time off per year (rolls over)
- Additional \$2/hour for overnight shift



## **Proposed Terms**

- Capital investment of \$50 million
- Minimum 175 full time jobs with benefits
- No rebate of property taxes 100% capture by City, County, ISD
- 50% sales tax rebate over 15 years assuming County participation
- Sign standards modified to allow for a 68' pole sign with sign face area up to 360 square feet prominently featuring San Marcos's name
- Company to donate \$100,000 to City community fund
- Rainwater harvesting, oil water separators, lighting standards
- Make effort to hire local residents, contractors and suppliers

## Potential Revenue to the City, County and ISD

Local Entity	Total Rebate	Total Sales Tax	Total Property Tax			
City	\$3.2M	\$3.2M	\$5.9M			
County	\$1M	\$1M	\$2.8M			
Hays CISD	\$0	\$0	\$11.4M			

Return on City incentive over 15 years:
(Gain of investment – cost of investment)/cost of investment
(\$12.3M property/sales taxes - \$3.2M in rebate)/ \$3.2M in rebate = 2.84 or 284%

15-year taxes collected to Hays County is \$3.8M (Net of sales tax rebate) 15-year taxes collected to Hays CISD is \$11.4M

### **EDSM Recommendation**

- Economic Development San Marcos Board voted 7-0 on December 18, 2023, to recommend this project and incentive to the City Council at the following level:
  - 50% sales tax rebate for 10 years
  - Assumes Hays County to match City incentive for the same term
- After additional benchmarking with other municipal Chapter 380 agreements, term was set at 15 years



#### **Staff Recommendation**

Staff recommends Council approve a Chapter 380 economic development incentive agreement as presented on next slide on second reading.
