Notification of Proposed Annexation by the City of San Marcos – AN-22-12 (Hampton Business Park)

Dear Public Entity Representative:

Under Local Government Code Chapter 43, cities are required to notify certain public entities of all proposed annexations. The San Marcos City Council is considering the following annexations that may affect your jurisdiction:

Annexation of a 69.407 acre +/- acre tract of land out of the William H. Van Horn Survey, Abstract No. 464, in Hays County, Texas, generally located between I-35 south and the Union Pacific railroad, approximately 1,000 ft south of Posey Road.

All annexations are subject to notification, public hearings, and vote by City Council. The annexation schedule is as follows:




