I. Call To Order

With a quorum present, the regular meeting of the San Marcos City Council was called to order by Mayor Hughson at 6:02 p.m. Tuesday, November 19, 2019 in the City Council Chambers, 630 E. Hopkins, San Marcos, Texas 78666.

II. Roll Call

III. Invocation

Reverend Craig DeYoung, with Our Lady of Wisdom University Parish provided this evening's invocation.

IV. Pledges Of Allegiance - United States And Texas

Devin Rodriguez, 2nd Grade Student at San Marcos Preparatory School, led the assembly in the pledges of allegiance.

V. 30 Minute Citizen Comment Period

Eric Martinez, voiced his support of the appointment to the Criminal Justice Reform committee. He looks forward to the recommendations that the committee will be bringing forward.

Phil Hutchinson made the following comments:

"My name is Phil Hutchinson, 202 E Mimosa Circle. I served on Planning and Zoning for 3 years back in 04,05 & 06 and later served on the Citizen's Utility Advisory board. I was president of the board of San Marcos Habitat for Humanity for 6 years and helped merge San Marcos Habitat with Austin Habitat which dramatically increased the investment by Habitat in our city. I also spend most Saturday mornings volunteering on Habitat build sites.

In my professional life I occasionally appear in front of planning commissions

or city councils to present on land developments.

I don't say all this to suggest I have any special expertise, only to add some texture to my comments. I have a personal commitment to affordable housing, the quality of development in San Marcos and some experience in the field of development.

I'm here to comment on a recent tweet by a city council person which I'd like to read:

"All the developers seeking to make big profits in SM from 'affordable housing' all have the same look: White, male, tall, wear blue blazers, money hungry, and emotionless... AND It feels damn good to vote against their proposed developments."

There are a few things that are disturbing about that tweet. It seems to be in violation of San Marcos Code of Ordinances 2.421 (a) General policy statement. It is the policy of the city that all city officials and employees shall conduct themselves both inside and outside the city's service so as to give no occasion for distrust of their integrity, impartiality or devotion to the best interest of the city and the public trust which the city holds.

This is the very first sentence in the Code of Ethics section of the ordinances. The bias expressed in this publicly shared tweet makes it impossible for anyone to believe this council person is objective, and the ethics review commission should investigate appropriate action. We can no longer be sure that an applicant has received or will receive an impartial assessment of their project, regardless of their race.

Also concerning is this person's criticism of "big profits" being made on affordable housing. The issue of affordable housing is extremely complex and is one being dealt with in cities all across the country. If we remove or marginalize profits for housing developers, we've eliminated an important tool in our effort to bring affordable housing to San Marcos.

I realize that an example has been set in this country for impulsive tweets. I just wonder if emulating our tweeter in chief is really where this council person wants to go or where we want to be as a city.

I urge you to take this matter seriously. The image of our city is an asset to be guarded and when one of us puts that image at risk it's the duty of those around that person to hold them accountable."

Gloria Salazar, spoke as a member of the Workforce Housing Taskforce, she brought up that the League of Women Voters had previously conducted a study that resembled the report that the workforce housing taskforce provided. This was an issue when the league was involved in back in early 2000s. She is asking that Council really try to bring affordable housing to San Marcos. Let's move forward.
