"FD" Future Development to "CC" Community Commercial
115 Flint Ridge Road**

ZC-21-04 (115 Flint Ridge Road) Hold a public hearing and consider a request by Doug Goss, Natural Development Austin, LLC, on behalf of Lazy Oaks Ranch, LP, La Cima Commercial LP, and LCSM PH 1-1, LLC, for a zoning change from "FD" Future Development to "CC" Community Commercial, or subject to consent of the owner, another less intense zoning district classification, for approximately 1.197 acres, described as Lot 2, La Cima Fire Station, located at 115 Flint Ridge Road.

The San Marcos Planning and Zoning Commission will consider the above request at an upcoming public hearing to obtain citizen comments and will either approve or deny the request. This recommendation will be forwarded to the San Marcos City Council. Before making a final decision, the Council will hold a public hearing to obtain citizen comments.
