



### Tapville Trailer Installation - San Marcos Mall Intent and Operational Overview

#### **Overview**

Tapville intends to permanently position its 16-tap mobile beverage trailer at San Marcos Mall.

This unit, previously operated as a mobile trailer, will be converted to function as a stationary kiosk-style installation for the purpose of state licensing and long-term operation.

# **Permanent Positioning**

The trailer will be installed on permanent blocks with wheels removed.

A corrugated metal skirt will wrap the base to give a fixed, architectural appearance.

The unit will be plugged into the mall's power supply (no generator will be used).

Potted plants and soft landscaping will surround the unit to enhance permanence and guest experience.

## **Operations**

The trailer will not move and will function like any other fixed food and beverage kiosk.

Draft lines will be cleaned on-site by a professional draft line service.

All cleaning and restocking will occur on-site using standard health department-approved practices.

All products, cups, supplies, and equipment will be stored within the trailer.

The unit operates as a self-contained beverage service point with no off-site dependency.

### **Summary**

This installation will serve as a visually permanent, fully operational Tapville fixed beverage service kiosk location.
