

SECOND AMENDMENT TO CONSENT AGREEMENT

This First Amendment to Consent Agreement (“Agreement”) is between the City of San Marcos, Texas (“the City”), a home-rule city located in Hays County, Texas, and LaSalle Holdings, Ltd. a Texas limited partnership (the “Developer”). City previously consented to the creation of four municipal utility districts together to include approximately 1,437 acres of land, at least partially within the extraterritorial jurisdiction of the City of San Marcos, Texas. The name of the Districts is the LaSalle Municipal Utility District Nos. 2-5 (the “Districts”). The Districts were created in the 83rd Legislative Session pursuant Texas Water Code Sections 49 and 54 by special act of the Texas legislature.

RECITALS

WHEREAS, The Developer owns approximately 1,437 acres of land located within the extraterritorial jurisdiction of the City (the “Land”).

WHEREAS, The City consented to the creation of LaSalle Municipal Utility Districts Nos. 2-5.

WHEREAS, The Consent Agreement has a term in Section 2.04 requiring a confirmation election to be held within two years from the districts’ creation of the legislature.

WHEREAS, The City and the Developer each desire to amend Section 2.04.

NOWTHEREFORE, FOR VALUABLE CONSIDERATION, The City and the Developer Agree as follows:

The Consent Agreement, in Section 2.04, shall be amended as follows:

“The City’s consent shall be deemed withdrawn and the Districts shall be dissolved if:

(a) The District has not held a confirmation election within ~~four (4)~~ six (6) years from the date of its creation by legislature;...”

All other provisions of the Consent Agreement remain the same.
