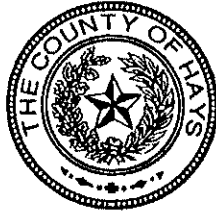


Dear Mr. Avila,
