3. Consider approval of Ordinance 2025-11, on the second of two readings, reducing the speed limit from 30 miles per hour to 25 miles per hour along portions of Tampico Street, Laredo Street, Saltillo Street, Durango Street, Juarez Avenue, Monterrey Street and

Luciano Flores Boulevard in the Wallace Addition Neighborhood; authorizing the installation of signs and traffic control devices reflecting the new speed limits; directing that the traffic register maintained under Section 82.067 of the San Marcos City Code be amended to reflect the new speed limits; and including procedural provisions.

- 4. Consider approval of Resolution 2025-84R, approving the award of a construction contract to Falkenberg Construction for the Police Station Improvements project in the estimated amount of \$938,153.70; authorizing the City Manager, or her designee, to execute the appropriate documents related to this contract on behalf of the city; and declaring an effective date.
- 5. Consider approval of Resolution 2025-85R, approving a three-year extension of a reciprocal Property Use Agreement between the City and Texas State University for the city's use of a parking area downtown and Texas State University's use of a parking area along Charles Austin Drive; authorizing the City Manager, or her designee, to execute this extension agreement on behalf of the city; and declaring an effective date.
- **6.** Consider approval of Resolution 2025-86R, approving an Advance Funding Agreement (AFA) Amendment between the City of San Marcos and the Texas Department of Transportation (TxDOT) for the San Marcos Shared Use Pathway project; to add Congressional Funding in the amount of \$1,095,940.00 (federal share \$986,346.00, local share \$109,594.00); authorizing the City Manager, or her designee, to execute the amendment on behalf of the city; and declaring an effective date.
- 7. Consider approval of Resolution 2025-87R, approving a fifth change in service to the engineering services agreement with BGE, Inc. relating to the Wallace Offsite Drainage Improvements project in the estimated amount of \$195,163.00 for a total contract price of \$1,831,381.00; authorizing the City Manager, or her designee, to execute the appropriate documents to implement the change in service; and declaring an effective date.
- 8. Consider approval of Resolution 2025-88R, approving an agreement with Gloria De La Rosa Garza for the purchase of a 2.998 acre tract of land located near the intersection of Redwood Road and FM 1978 for a price of \$195,000.00, plus associated closing costs, in connection with the Wastewater Treatment Plant second site (571) project; authorizing the City Manager, or her designee, to execute said agreement and associated closing documents on behalf of the city; and declaring an effective date.
- 9. Consider approval of Resolution 2025-89R. accepting the award special commissioners in the amount of \$408,500.00 in Cause No. 24CV-07636, Caldwell County Court at Law, in connection with the city's acquisition of a water line, wastewater line, and recycled water line easement and right-of-way along State Highway 80 between Old Bastrop Road and FM 110 from Mary Beth Harper a/k/a/ Mary Nance Harper, individually and as independent executor of the estate of Ray Stewart Harper, and Jaime Lynn Harper; authorizing the city's legal counsel to deposit such amount in the registry of the court and to pay associated costs on behalf of the city; and declaring an effective date.
- 10. Consider approval of Resolution 2025-90R, authorizing the re-submission of an application to the Motor Vehicle Crime Prevention Authority for a grant in the amount of \$6,500.00 for the continued maintenance and operation of ten license plate reader cameras for use in

addressing motor vehicle and catalytic converter thefts; authorizing the City Manager, or her designee, to execute any and all documents as needed to apply for, accept, implement, decline, modify, or cancel the grant, if awarded; and declaring an effective date.

- 11. Consider approval of Resolution 2025-91R, authorizing the re-submission of a taskforce grant application to the Motor Vehicle Crime Prevention Authority for a grant in the amount of \$177,401.00 to fund the continuing operation of an auto crimes unit within the police department, including funding for one full-time sworn officer position and nine license plate reader cameras; this is to keep the same level of service and not requesting any additional cameras; authorizing matching funds in the amount of \$36,585.00; authorizing the City Manager, or her designee, to execute any and all documents as needed to apply for, accept, implement, decline, modify, or cancel the grant, if awarded; and declaring an effective date.
- 12. Consider approval of Resolution 2025-92R, awarding a contract to Matrix Consulting Group to conduct a departmental staffing study for the police department in an amount not to exceed \$116,000.00; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.
- 13. Consider approval of Resolution 2025-93R, approving a contract with IPS Group Inc. through the Omnia Partners Purchasing Cooperative for parking enforcement software and equipment with an initial term of thirteen months for \$96,950.00 plus the annual service cost and allowing for four additional annual renewals with the annual service cost of \$51.056.00 per year for a total contract amount of \$352.232.00; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.

Consider approval of Resolution 2025-94R, approving a Memorandum of Understanding with the Texas Department of State Health Services (DSHS) providing for utility department participation in the DSHS Wastewater Monitoring Program; authorizing the City Manager, or her designee, to execute the Memorandum of Understanding on behalf of the city; and declaring an effective date.

Consider approval of Resolution 2025-95R, approving an agreement with the Edwards Aquifer Authority (EAA) for the installation of equipment on City of San Marcos property to facilitate automatic meter readings of the city's regulated meters; authorizing the City Manager, or her designee, to execute this agreement on behalf of the city; and declaring an effective date.

Consider approval of Resolution 2025-96R, approving the terms and conditions of an interlocal agreement between the City of San Marcos and Hays County for the operation of a household hazardous waste drop-off facility located in San Marcos for all city and county residents; authorizing the City Manager, or her designee, to execute this agreement on behalf of the city; and declaring an effective date.

Consider approval of Resolution 2025-97R, approving a Change in Service to the contract with GDS Associates, Inc. for a utility rate study to increase the contract amount by \$41,000.00 for a total contract amount of \$183,000.00, and to clarify the contract term; authorizing the City Manager, or her designee, to execute the appropriate documents to

implement the change in service; and declaring an effective date.

Consider approval of Resolution 2025-98R, approving an agreement for the provision of services in connection with the proposed owner requested annexation in Case No. AN-25-04 of approximately 10.03 acres of land known as UMC Subdivision Lot 1, generally located 1,300 feet southeast of the intersection of Clovis Barker Road and Leah Avenue, along with the adjacent county right-of-way, in Hays County, Texas; authorizing the City Manager, or her designee, to execute said agreement on behalf of the city; setting a date for a public hearing concerning the proposed annexation of said tract of land; and declaring an effective date.

Consider approval of Resolution 2025-99R, approving a contract with the nonprofit Wings of Warriors Organization for the Texas Capital Air Show San Marcos in the amount of \$100,000.00 of hotel occupancy tax to support marketing efforts for the air show to be held, November 1 2, 2025; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.
