The San Marcos river is already suffering the impacts of our residential and small commercial growth; we can not sustain any kind of industrial growth. A data center will not only drain our water resources, but will also increase electricity demand and prices on an already economically stressed community.

There is no good reason to adjust our already developed 10 year strategic plan. The strategic plan was developed with community input for over two years and was intended to serve our city for the next 10-15 years; there is NO good reason to change it after 15 months.

I am a local to San Marcos. Born and raised.
I've also been fortunate to be able to purchase a home here, so I can continue to invest into my community for years to come. I've seen devastating droughts (which we are currently facing). I've watched new developments pop up in recorded breaking time causing water run off when it rains to not seep into our recharge zones but instead flood and wreak havoc in unexpected neighbors. I've watched 5-mile dam go from a flourishing ecosystem to a desolated pile of dirt and brush.
What is the turtles or the herons or the salamanders benefit of moving forward with this plan?
