



City Requirements

San Marcos Development Code Section 3.5.2.4 Electric:

A. The installation of new electrical distribution infrastructure shall be installed underground in accordance with Chapter 86 of the City Code of Ordinances.

City Code of Ordinances, Chapter 86, Article 4, Division 4, Section 86.188 – Standards for development:

(a) Any new development in the City Limits shall have underground electric utilities..




Whisper South Appeal

Appeal to City Council



House Bill No. 14 passed in June 2023, in effect September 1, 2023

San Marcos Development Code was amended to allow for appeals to City Council, per Section 2.2.4.3.A stating the following:


"Where a development application does not include a provision for appeal, or where City Council is not the appeal body an applicant may appeal to City Council.....No hearing shall be required for this appeal."

Overhead Electric Considerations



Included in the request by the applicant:

- 1. Overhead Electric Exists
- 2. Floodplain in the area
- 3. LCRA Transmission Lines Exist Overhead
- 4. Overhead provides greater flexibility to adjust lines or provide greater loads



Underground Electric Considerations

1. Improved Safety

1. Reduced risks of accidents and injuries caused by contact with overhead lines.

2. Enhanced Reliability

1. Less vulnerable to damage from storms, winds, and other external factors.

3. Aesthetically Pleasing

1. Do not require the use of poles and wires, compounded by telecommunication lines

4. Improved Security

1. Less vulnerable to tampering

5. Environmental Benefits

- 1. Might lessen emissions
- 2. Protect wildlife by reducing the risk of collisions with overhead lines

Recommendation



Staff recommends <u>denial</u> of the appeal requesting the installation of Overhead Electric Facilities.

Alternative recommendation if City Council were to consider approval of the appeal, staff recommends limiting the Overhead Electric Facilities to the portion of the request between IH-35 and Harris Hill Road.
