Consider approval of Ordinance 2025-20, on the second of two readings, annexing into the City approximately 10.03 acres of land known as UMC Subdivision Lot 1 (including adjacent right-of-way) in Hays County, Texas, generally located southeast of Clovis Barker Road and Leah Avenue (Case No. AN 25-04); including procedural provisions; and declaring an effective date.
- 2. Consider approval of Ordinance 2025-21, on the second of two readings, amending the Official Zoning Map of the City in Case ZC-25-07, by rezoning approximately 10.03 acres, known as UMC Subdivision Lot 1, generally located southeast of Clovis Barker Road and Leah Avenue, from Future Development (FD) to Heavy Commercial (HC) or, subject to the consent of the owner, another less intense zoning district classification; including procedural provisions; and declaring an effective date.

- 3. Consider approval of Ordinance 2025-22, on the second of two readings, amending the Official Zoning Map of the city in Case No. ZC-25-06 by rezoning approximately 26.77 acres of land generally located on East McCarty Lane south of the intersection between Rattler Road and East McCarty Lane from Character District-4 (CD-4) to Character District-5 (CD-5), or subject to consent of the owner, another less intense zoning district classification; including procedural provisions; and declaring an effective date.
- 4. Consider approval of Ordinance 2025-23 on the second of two readings, amending Section 2.506 of the San Marcos City Code to substitute the Chief of Police with the Director of Information Technology on the Records Management Committee under the city's Public Records Management Program; including procedural provisions; and declaring an effective date.
- 5. Consider approval of Resolution 2025-126R, concerning Project Cat Tree and approving a Chapter 380 Economic Development Incentive Agreement with Midway Development, LLC providing incentives in the form of partial rebates of hotel occupancy and sales taxes over ten years for the construction of a full-service downtown hotel at 429 North Guadalupe Street with a minimum capital investment by midway of \$40,000,000.00; authorizing the City Manager, or her designee, to execute the appropriate documents related to this agreement on behalf of the city; and declaring an effective date.
- **6.** Consider approval of Resolution 2025-127R, nominating Midway Development Group to the Office of the Governor, Economic Development and Tourism, through the Economic Development Bank as an enterprise project pursuant to the Texas Enterprise Zone Act; and declaring an effective date.
- 7. Consider approval of Resolution 2025-128R, approving a Second Amended and Restated Lease with the San Marcos Lions Club for the Lions Club to lease a portion of the Pauline Espinosa Community Hall located in City Park for a term of five years with an annual rent in the amount of \$12,500.00, with an option to renew for up to one additional five-year term upon mutual agreement; authorizing the City Manager, or her designee, to execute said lease; and declaring an effective date.
- 8. Consider approval of Resolution 2025-129R, approving the reallocation of \$77,025.44 in funds received by the City of San Marcos under the American Rescue Plan Act (ARPA) to support the recovery of the community from COVID-19; authorizing the City Manager, or her designee, to execute any related documents; and declaring an effective date.
- **9.** Consider approval of Resolution 2025-130R, approving a contract with Altus Traffic Management, LLC, d/b/a AWP Safety, for traffic control and lane closure services necessary for safe utility work to be performed in high traffic areas for five years for an annual amount not to exceed \$50,000.00 and a total contract price not to exceed \$250,000.00; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.
- 10. Consider approval of Resolution 2025-131R, approving a contract with Lonestar Forklift, through the Sourcewell Purchasing Cooperative, for the purchase of a Hyundai 100d-9V Diesel Forklift for use by the Utilities Department in the amount of \$143,931.00; authorizing

the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.

- 11. Consider approval of Resolution 2025-132R, approving a contract with DLT Solutions, LLC, utilizing the Texas Department of Information Resources contract number DIR-CPO-5677, for the purchase of Autodesk drafting, design and modeling software and support for an initial one year term in the amount of \$30,291.80, with the option to renew for up to four additional one year periods, for a total estimated cost, including any price increases, of \$184,934.47; authorizing the City Manager, or her designee, to execute the contract and any renewals on behalf of the city; and declaring an effective date.
- 12. Consider approval of Resolution 2025-133R, approving a contract with NWN Carousal, through the Choice Partners Purchasing Cooperative, for the purchase of an audio visual solution including equipment, professional services, for a five year term to include maintenance for use in the Public Services Complex, San Marcos Activity Center and San Marcos Public Library in the amount of \$686,929.51; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.
- 13. Consider approval of Resolution 2025-134R, approving a contract with GenServe, through the Buyboard Purchasing Cooperative, for preventative maintenance service for city facility generators, water booster stations and wastewater lift stations in the amount of \$180,000.00; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.
- 14. Consider approval of Resolution 2025-135R, authorizing an Advanced Funding Agreement (AFA) with the Texas Department of Transportation, relating to the Wallace Addition Offsite Drainage Improvement Project, to provide for the installation of reinforced concrete box storm drain system along and across FM 621, within TxDOT right of way, with a cost to the city of \$1,432,909.00; authorizing the City Manager, or her designee, to execute the appropriate documents to implement the AFA on behalf of the city; and declaring an effective date.
- 15. Consider approval of Resolution 2025-136R, approving a sixth Change in Service to the engineering services contract with BGE, Inc. relating to the Wallace Offsite Drainage Improvements project in the amount of \$135,838.00 for a total contract price of \$1,967,219.00; authorizing the City Manager, or her designee, to execute the change in service on the behalf of the city; and declaring an effective date.
- 16. Consider approval of Resolution 2025-137R, approving a reimbursement agreement with Union Pacific Railroad Company providing for the city to reimburse the railroad for the cost of plan review services to be incurred by the railroad due to work affecting railroad property necessary for the city's Purgatory Creek Improvements project in an amount not to exceed \$300,000.00; authorizing the City Manager, or her designee, to execute the agreement on behalf of the city; and declaring an effective date.

Consider approval of Resolution 2025-138R, approving a contract with Meeder Public Funds Inc. for investment management services over a period of two years, with fees in the amount of three basis points (0.03%) of assets, to include securities and bonds under management in the custodial account; authorizing the City Manager, or her designee, to
