Grantor, for the Consideration, grants, sells and conveys to Grantee, its successors and assigns, a non-exclusive easement, over, across, through and under the Easement Area for the purposes of installing, erecting, constructing, operating, repairing, replacing, upgrading, enlarging, relocating, inspecting and maintaining underground electric distribution lines or systems, telecommunication lines or systems, and associated above-ground appurtenances and equipment (the "Electric Facilities"), together with the right of ingress and egress over the Easement Area for such purposes. The foregoing grant and rights are collectively referred to herein as the "Easement").

TO HAVE AND TO HOLD the Easement and rights and interests herein granted to Grantee and Grantee's successors or assigns forever. Grantor binds Grantor and Grantor's heirs, executors, administrators, successors and assigns to warrant and forever defend this Easement to Grantee and Grantee's successors and assigns against every person whomever lawfully claiming or to claim the same or any part thereof, when the claim is by, through or under Grantor, but not otherwise.

Any above-ground appurtenances and equipment shall be allowed only in Area No. 2 and Area No. 3. Grantee's right of ingress and egress may extend to Grantor's adjacent property as reasonably necessary for Grantee to carry out the foregoing activities, subject to Grantor's right to approve access routes and other terms of use of such adjacent property.

Grantee shall restore the surface of and plant new grass in any portions of the Easement Area and adjacent property damaged as a result of excavation or other activities of Grantee in connection with this Easement. Grantee, however, shall have the right to cut, trim, and control the growth of trees and other vegetation, which interferes with or threatens the operation and maintenance of the Electric Facilities.
