A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS AWARDING A CONTRACT TO ACTION TARGET, A GENERAL SERVICES ADMINISTRATION CERTIFIED VENDOR, TO INSTALL A TOTAL BULLET CONTAINMENT TRAP AT THE POLICE DEPARTMENT'S SHOOTING RANGE IN THE AMOUNT OF \$643,800.00; AUTHORIZING THE CITY MANAGER, OR HER DESIGNEE, TO EXECUTE THE CONTRACT ON BEHALF OF THE CITY; AND DECLARING AN EFFECTIVE DATE.
