I. Call To Order

With a quorum present, the regular meeting of the San Marcos City Council was called to order by Mayor Pro Tem Thomaides at 5:01 p.m. Tuesday, September 6, 2016 in the City Council Chambers, 630 E. Hopkins, San Marcos, Texas 78666.

Mayor Guerrero was absent due to business travel.

III. Invocation

Reverend Scottie McIntyre Johnson with San Marcos Unitarian Universalist provided this evenings invocation.

Council Member Hughson led the assembly in the Pledges of Allegiance.

EXECUTIVE SESSION

Receive a presentation and hold discussion regarding the final Plan in compliance with HUD Community Development Block Grant -Disaster Recovery (CDBG-DR) Federal Register Notice 5938-N-01 for a \$25,080,000 HUD CDBG-DR Grant for 2015 flood recovery, and provide direction to Staff.

Collette Jamison, Assistant City Manager, introduced AECOM Project Manager Marisa Mason and Planning Manager, Lael Holton. Mr. Holton provided the Council with a presentation of the final Action Plan that will be submitted to HUD. Council inquired about the pros and cons of using all of the funding for housing solutions or options and securing other sources of funding to address infrastructure projects and other needs. Council also discussed using economic development funds to hire a consultant to provide technical assistance to homeowners in the flood prone areas. Council provided direction to submit the final Action Plan.

V. 30 Minute Citizen Comment Period

Larry Mock, represented Protect San Marcos, spoke about their mission and spoke about a petition that they posted on Facebook and that it had over 1000 signatures of individuals that don't want the HEB located at Wonder World and Hunter Road. They provided the petition to the City Clerk and Council.

Jennifer Fischer, addressed the Council regarding the proposed HEB. She stated that spoke with several people in the community and she stated that all of them were against the proposed HEB project and how the people on the east side would like it over there. She spoke about how they want a government that stands for the people. She stated that the City provided this to P&Z and broke the law.

Brian Olson, spoke to the Council about Cape's Dam and how he had never seen so many flat out lies as those that were provided by Mike Montagne. He reviewed several points about the presentation that he considers inaccurate.

He spoke about meetings between Mike Montagne, Melanie Howard and Dr. Hardy that had taken place prior to anything being brought before the Parks Department or City Council, and the timeliness of the offer from US Fish to remove the dam. He provided several other documents in support of his position to keep Cape's Dam.

Lisa Marie Coppoletta, addressed the Council about potentially giving the Ethics Review Commission the oversight of consultants. She said that the recent downtown parking event was around \$85,000. She provided a shout out to the Police patrolling the Historic District. She stated that we won't have the finalized FEMA flood maps until summer of 2017. She encouraged the use of more permeable materials on things like sidewalks and parking lots and provided her reasons for wishing to see these materials utilized.

Joan Byrd, provided the Council with comments regarding the master plan that was recently approved and the amount of time and work that it took to put it in place. She asked the Council to not vote against the master plan.

Charles Soechting, stated that he was present representing the Lara family on the HEB deal. He spoke about the Lara Family and HEB meeting on several occasions and that the Lara Family is supportive of this project. He stated that HEB is the only grocery store ever to be given a Green Award for their green building models. He welcomes the time to speak more about this and spoke about how HEB has addressed every possible concern.

Rob Roark, referenced the law suit that the City is involved in with the Lara Family. He referenced the Land Use Plan in 2002 and spoke about the wonder world extension and the limited access off of the extension regarding the curb cuts that were promised wouldn't happen. He stated that the Lara's are going to be taken care of, but he asked the Council to follow the plan. He stated that once we start making those changes off of Wonder World that more requests will come in.

Robert Moore, representing the Cemetery Commission spoke about their planned clean ups in the fall and asked citizens to clean their plots prior to the cleanup. He stated that anything collected during the cleanup will be taken to the caretaker's office for retrieval.

Ivan Friedman, addressed the Council and asked that the Council send the HEB item back to P&Z. He stated that we already have two HEB stores on the west side and that the east side of town only has Wal-Mart. He stated that

everyone should have equal opportunity for access to fresh produce. He stated that we should buy this property for parkland.

Andy Greenwood, spoke to the Council regarding placing time limits on certain decibel levels for outdoor clubs and bars. He asked that the Council address amplified music after midnight and stated how it is negatively impacting their neighborhood.
