Consider approval of Resolution 2024-130R, approving a partial release of a wastewater easement located between Premier Parkway and Post Road in the Champions Business Park, such part of the easement being no longer necessary; authorizing the City Manager, or her designee, to execute the partial release of easement on behalf of the city; and declaring an effective date.
- 2. Consider approval of Resolution 2024-131R, authorizing a Local On-System Agreement ("LOSA") with the Texas Department of Transportation, relating to the Briarwood and River Ridge Drainage Improvement Project, to provide for necessary construction of a detention pond outfall along the IH-35 frontage road, in the amount of \$584,065.00; authorizing the City Manager, or her designee, to execute the appropriate documents to implement the LOSA on behalf of the city; and declaring an effective date.

- 3. Consider approval of Resolution 2024-132R, approving a Release and Partial Release of Wastewater Easements located near Posey Road and IH 35 and expending \$35,505.00 and closing costs in exchange for a larger wastewater easement saving operational money for an abandoned lift station, under the terms of an Easement Exchange Agreement with BKCK, Ltd., a Texas limited partnership; authorizing the City Manager, or her designee, to execute necessary documents on behalf of the city; and declaring an effective date.
- 4. Consider approval of Resolution 2024-133R, approving a professional services agreement with Lopez Salas Architects, Inc., for city facility space planning and cost estimating services in the amount of \$247,719.50; authorizing the City Manager, or her designee, to execute the agreement on behalf of the city; and declaring an effective date.

Consider approval of Resolution 2024-134R, approving a contract with Survalent Technology, Inc., for the supply and installation of an Electric Supervisory Control and Data Acquisition (SCADA) System for the Utilities Division for an estimated total contract amount of \$522,733.49; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.
- 6. Consider approval of Resolution 2024-135R, approving a contract with NWN Corporation to upgrade the Emergency Operations Center room at the city's Public Services Complex in the amount of \$219,052.67 from funds received by the City under the American Rescue Plan Act; authorizing the City Manager, or her designee, to execute the agreements and any necessary related documents on behalf of the city; and declaring an effective date.
- 7. Consider approval of Resolution 2024-136R, approving an Amended and Restated Interlocal Cooperation Agreement regarding the Austin Regional Intelligence Center (ARIC) and the Interlocal Cooperation Agreement for sustainment funding for ARIC that enables the Police Department and other regional law enforcement agencies to share information; authorizing the City Manager, or her designee, to execute the agreement on behalf of the city; and declaring an effective date.

Receive a Staff presentation and hold a Public Hearing to receive comments for or against Resolution 2024-137R, adopting the Community Development Block Grant ("CDBG") Action Plan that provides for the allocation of \$1,405,990.00 in CDBG entitlement funds for program year 2024-2025; authorizing the City Manager, or her designee, to act as the official representative of the city in matters related to the CDBG Program and Action Plan; and declaring an effective date; and consider approval of Resolution 2024-137R.
- 9. Receive a Staff presentation and hold a Public Hearing to receive comments for or against Ordinance 2024-27, annexing into the City approximately 7.553 acres of land (inclusive of a portion of county right-of-way) in Caldwell County, Texas, generally located on the

western side of FM 1984 approximately 4,600 feet northeast of the intersection between State Highway 80 and FM 1984, and approximately 150 feet northeast of the intersection between FM 1984 and Foster Boulevard (Case No. AN-24-03) (AXIS Logistics); including procedural provisions; and providing an effective date; and consider approval of Ordinance 2024-27, on the first of two readings.

- 10. Receive a Staff presentation and hold a Public Hearing to receive comments for or against Ordinance 2024-28, annexing into the City approximately 7.913 acres of land in Hays County, Texas, generally located on the south side of Ranch Road 12, approximately 1,200 feet northwest of west Centerpoint Road, in Case No. AN-24-04 (La Cima PEC substation); including procedural provisions; and providing an effective date; and consider approval of Ordinance 2024-28, on the first of two readings.
- 11. Receive a Staff presentation and hold a public hearing to receive comments for or against Ordinance 2024-29, amending the Official Zoning Map of the City in Case No. ZC-24-05 (La Cima PEC substation), by rezoning approximately 7.5 acres of land in Hays County, Texas, generally located on the south side of Ranch Road 12, approximately 1,200 feet northwest of west Centerpoint Road, from Future Development "FD" District to Character District 1 "CD-1", or, subject to consent of the owner, another less intense zoning district classification; including procedural provisions; and providing an effective date; and consider approval of Ordinance 2022-29, on the first of two readings.

Receive a staff presentation and hold a public hearing to receive comments for or against Ordinance 2024-30, annexing into the City approximately 3.43 acres of city-owned land, known as Rattler Substation, in Hays County, Texas, generally located southeast of the intersection of Clovis Barker Road and Leah Avenue (Case No. AN-24-05); including procedural provisions; and providing an effective date; and consider approval of Ordinance 2024-30, on the first of two readings.
