AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS AMENDING THE CITY'S 2024-2025 FISCAL YEAR BUDGET TO ADJUST EXPENDITURE ACCOUNTS IN THE WATER AND WASTEWATER SPECIAL SERVICES FUND, COMMUNITY ENHANCEMENT FUND AND TIRZ #5 FUND; INCLUDING PROCEDURAL PROVISIONS; AND PROVIDING AN EFFECTIVE DATE.
