1. Provide a detailed project description for the proposed project(s). *

This application is funded by a FY2017 award of small urban Section 5339, Bus and Bus Facilities funds in the amount of \$72,277 for the acquisition of bus rolling stock for San Marcos urbanized area paratransit operations for up to one 25 ft bus for replacement. The Texas Department of Transportation (TxDOT) has awarded Transportation Development Credits (TDC) as local match in the amount of \$14,456. The bus will be used throughout the San Marcos urbanized area.

The funds were original slated to go to Capital Area Rural Transportation System (CARTS) as the direct recipient of the San Marcos urbanized area. The role of the direct recipient transferred to the City of San Marcos on October 1, 2019. These funds are set to lapse in September 2020. The City of San Marcos is actively seeking to program this capital project in the 2019-2022 Transportation Improvement Program (TIP) administered by the Capital Area Metropolitan Planning Organization.

Amendment to this project may occur in the future to include FY2018, FY2019, FY2020 Section 5339 Bus and Bus Facilities funds apportioned to the San Marcos urbanized area.

2. Provide justification regarding why TDC are needed. *

Use of TDCs would maximize the utilization of federal funds on this project and replace valuable local resources in execution of the project.

Identify how the project(s) meets the TDC program goals. *

The TDCs requested in this project were allocated by TxDOT (letter attached). This is a request to utilize those TDCs in a rolling stock aquisition to maintain State of Good Repair for the San Marcos urbanized area. This new paratransit bus will replace an older vehicle which was aquired in 2013.
