NO SEPARATE DISCUSSION OR ACTION ON ANY OF THE ITEMS IS NECESSARY UNLESS DESIRED BY A COUNCIL MEMBER, IN WHICH EVENT THE ITEM SHALL BE CONSIDERED IN ITS NORMAL SEQUENCE AFTER THE ITEMS NOT REQUIRING SEPARATE DISCUSSION HAVE BEEN ACTED UPON BY A SINGLE MOTION.

Consider approval of Ordinance 2025-49, on the second of two readings, amending the project plan and reinvestment zone financing plan for the Tax Increment Reinvestment Zone No. 5, Downtown TIRZ, to increase funding in support of an annual downtown operations and project plan; authorizing the City Manager, or designee, to execute the amendment on behalf of the City; including procedural provisions; and declaring an effective date.
- 2. Consider approval of Ordinance 2025-50, on the second of two readings, amending the Official Zoning Map of the City by rezoning approximately 26.76 acres of land generally located southwest of the intersection of Wonder World Drive and State Highway 123, from Future Development (FD) District to Character District-5 (CD-5) or, subject to the consent of the owner, another less intense zoning district, including procedural provisions; and declaring an effective date.

- 3. Consider approval of Ordinance 2025-51, on the second of two readings, amending Section 2.333 of the San Marcos City Code regarding duties of the Human Services Advisory Board to change reporting requirements for outside agencies from quarterly to annually and remove the requirement for the board's monitoring of payments to outside agencies to be quarterly; including procedural provisions; and declaring an effective date.
- 4. Consider approval of Ordinance 2025-52, on the second of two readings, amending the City's 2025-2026 Fiscal Year Budget to carry forward funds from the 2024-2025 Fiscal Year to adjust revenue and expenditure accounts in multiple operating, special revenue, and internal service funds; including procedural provisions; and declaring an effective date.
- 5. Consider approval of Ordinance 2025-53, on the second of two readings, increasing the speed limit from 60 miles per hour to 65 miles per hour on northbound and southbound FM 110, from approximately south of Yarrington Road to north of State Highway 80; authorizing the installation of signs and traffic control devices reflecting the new speed limits; directing that the traffic register maintained under Section 82.067 of the San Marcos City Code be amended to reflect the new speed limits and penalties to be applied; including procedural provisions; and declaring an effective date.
- 6. Consider approval of Resolution 2025-236R, setting an additional public hearing date in connection with the proposed owner requested annexation in Case No. AN-25-02 (900 Block Francis Harris Lane) of approximately 63.578 acres of land, generally located between Francis Harris Lane and York Creek Road, approximately 1,200 feet east of the intersection between York Creek Road and Caney Creek Road in Hays County, Texas; and declaring an effective date.
- 7. Consider approval of Resolution 2025-237R, approving a Change in Service to the Agreement with Weston Solutions for engineering design services for the Lift Station 23 Improvements Project (Near IH-35 and the Blanco River) for additional services in the amount of \$194,331.99; authorizing the City Manager, or her designee, to execute the Change in Service on behalf of the City; and declaring an effective date.
