Consider approval of Ordinance 2022-45, on the second of two readings, amending the Official Zoning Map of the City in Case No. ZC-22-24, by rezoning approximately 136.912 acres generally located at 900 Francis Harris Lane, from "FD" Future Development District to "CD-2.5" Character District 2.5, or, subject to consent of the owner, another less intense zoning district classification; including procedural provisions; and providing an effective date.
- 5. Consider approval of Ordinance 2022-58, on the second of two readings, amending the Official Zoning Map of the City in Case No. ZC-22-10, by rezoning approximately 202.2 acres, generally located 800 feet east of the Centerpoint Road and Centerpoint Court intersection and on the north side of Centerpoint Road, from "SC" Smart Code District to "LI" Light Industrial District, or, subject to consent of the owner, another less intense zoning district classification, including procedural provisions; and providing an effective date.
- 6. Consider approval of Ordinance 2022-59, on the second of two readings, amending the Official Zoning Map of the City in Case No. ZC-22-12, by rezoning approximately 173.05 acres generally located at the northwest corner of the Centerpoint Road and South Old Bastrop Highway Intersection from "SC" Smart Code District to "CD-3" Character District-3, or, subject to consent of the owner, another less intense zoning district classification, including procedural provisions; and providing an effective date.
- 7. Consider approval of Ordinance 2022-60, on the second of two readings, amending the Official Zoning Map of the City in Case No. ZC-22-13, by rezoning approximately 48.87 acres generally located on the north side of Centerpoint Road between Old Bastrop Highway and Centerpoint Court from "SC" Smart Code District to "CD-5" Character District-5 and "CD-3" Character District-3; including procedural provisions; and providing an effective date.
- 8. Consider approval of Ordinance 2022-69, on the second of two readings, amending Chapter 74, Article 6 of the San Marcos City Code related to Sidewalk Cafes, Parklets, and Similar Special Uses of Public Rights-of-Way, by, among other things, adding a definition and criteria for sidewalk seating areas, and deleting provisions for the 2020 Temporary Parklets Program related to the COVID-19 pandemic; providing a savings clause; providing for the repeal of any conflicting provisions; and providing an effective date.
- **9.** Consider approval of Ordinance 2022-70, on the second of two readings, amending the project plan and reinvestment zone financing plan for Tax Increment Reinvestment Zone No. 5, also known as the "Downtown TIRZ" to allocate funding in support of an annual downtown operations plan and approved project plans submitted via an application process; authorizing the City Manager, or her designee, to execute such amendments on behalf of the City; including procedural provisions; and declaring an effective date.
- **10.** Consider approval of Resolution 2022-189R, adopting a revised Investment Policy for Operating and Reserve Funds; and declaring an effective date.
- **11.** Consider approval of Resolution 2022-190R, approving an award of a contract to Electric Cab North America for Microtransit Solution services in an amount not to exceed \$500,000.00; authorizing the City Manager or her designee to execute the contract on

behalf of the City; and declaring an effective date.

Consider approval of Resolution 2022-191R, approving a contract with Walker Engineering, Inc. through the Texas Interlocal Purchasing System Cooperative (TIPS) for the replacement of fluorescent light fixtures with LED fixtures at the San Marcos Police Department in the estimated amount of \$108,090.39; authorizing the City Manager or her designee to execute the contract on behalf of the City; and declaring effective date.

AN-22-17 of approximately 38.586 acres of land, generally located at the southwest corner of the West Centerpoint Road and Central Park Loop intersection; authorizing the City Manager, or her designee, to execute said agreement on behalf of the City; setting a date for a Public Hearing concerning the proposed annexation of said tract of land; and declaring an effective date.

Consider approval of Resolution 2022-198R, approving an assignment of Electric Utility Easement to Lower Colorado River Authority (LCRA) Transmission Services Corporation, subject to the City's reservation of rights to operate and maintain city electric distribution facilities in the easement; authorizing the City Manager, or her designee, to execute the assignment of easement on behalf of the City; and declaring an effective date.

Consider approval of Resolution 2022-199R, authorizing a Change in Service to the agreement with Cobb Fendley & Associates, Inc. related to the Reconstruction of Downtown Alleys project for additional design phase tasks for Kissing Alley improvements from Hopkins Street to Hutchison Street in the amount of \$229,969.75; authorizing the City Manager or her designee to execute the appropriate documents to implement the Change in Service on behalf of the City; and declaring an effective date.
