Aerial Map



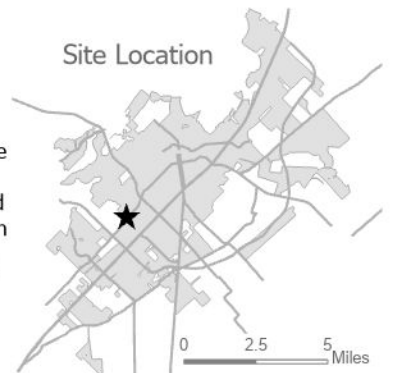

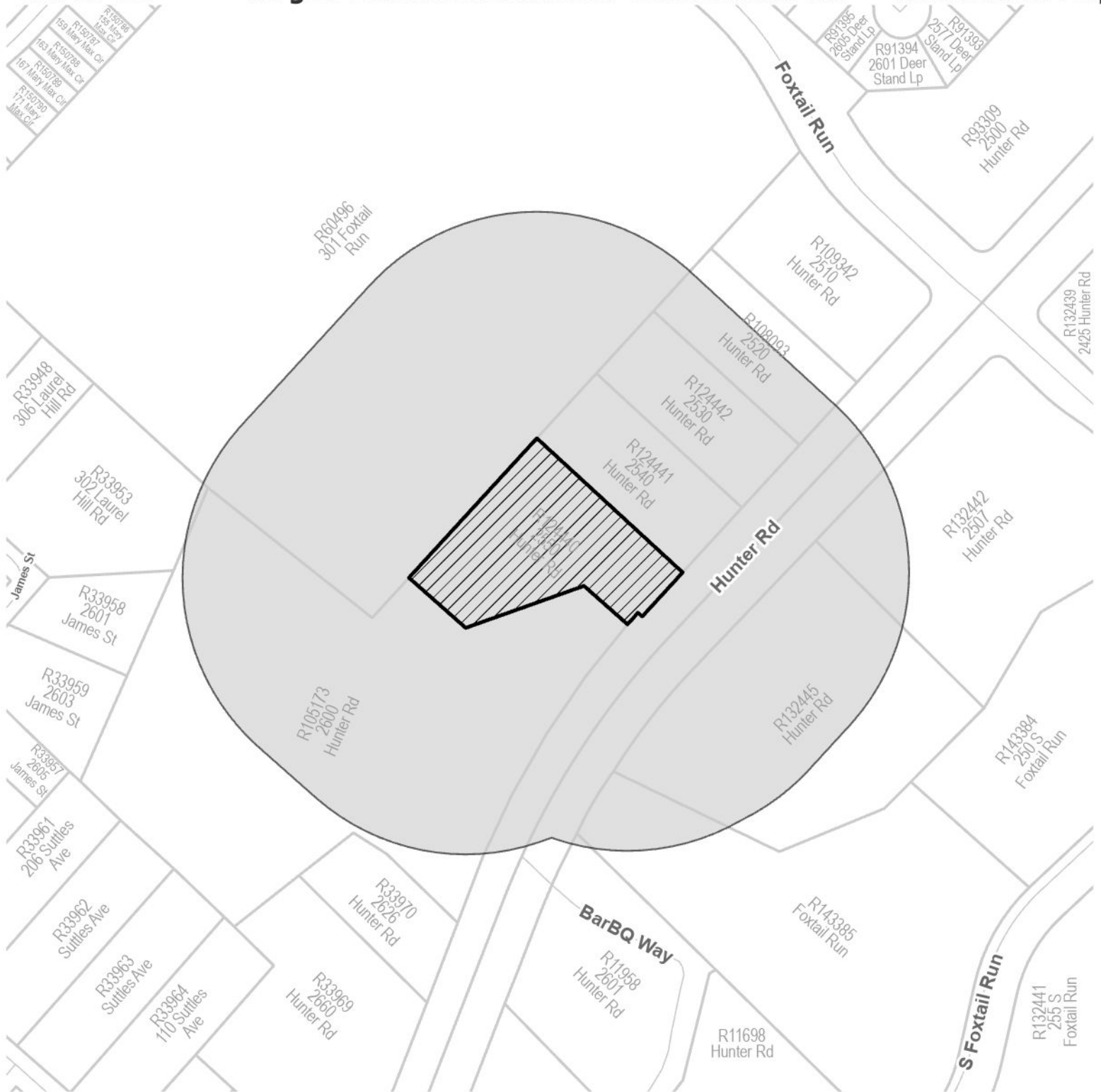

Notification Map



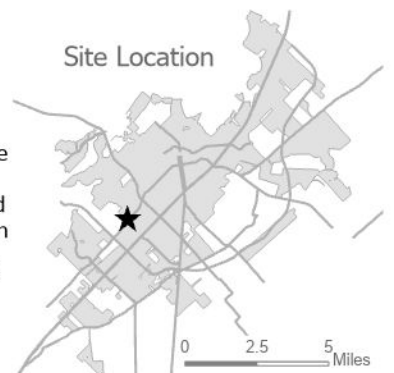
