## Why?



- The last time our Special Events Ordinance was updated was almost 15 years ago.
- Will create a more streamlined process for our Citizens and a central location (MyGovernmentOnline) for permits.
- Will help ensure:
  - Consistency
  - Safety
  - Equity

## **Progress to date**



- 2019/2020: City Staff began to work on updating our Special Events
  Ordinance, Chapter 19 of City Code. COVID hit and all Special Event
  permits were moved to the Department of Emergency Management with
  changes to the ordinance put on hold.
- **Spring 2023 To Date:** City Staff from the following departments have been meeting to go through the ordinance to propose the redline changes presented:
  - Animal Services
  - Code Compliance
  - Communications
  - Destination Services (Arts and Main Street)
  - Emergency Management

## **Notable changes**



- Special event definition
  - Changed from 100 people to 500 people
  - Or, 250 people if alcohol is sold
  - Or, if a road is closed.

 Responsible official has been moved from Chief of Police to the Fire Code Official.

## Notable changes continued



#### Permit Application deadline

60 days versus the current 20 days

#### Clarification for permit application requirements

Addition of email address, site plan, emergency action plan etc.

#### Insurance requirements

- Removed City Manager's authority to waive this requirement
- Removed the bond requirement

#### Permit Determination Form

Additional step in the process

#### Notable changes continued



- The following exemptions have been <u>removed</u> for consistency and equity.
  - City involvement or an event on City property is <u>not a reason to</u> <u>exempt the event</u>.
    - City Parks
    - An event sponsored by the City
    - Parades
  - Dependent upon the location and # of people attending, most of the following will not need a permit.
    - School events on school owned property
    - Events held by a religious organization on their own premise
    - Private events not open to the public.
