# Vision SMTX Comprehensive Plan



- Establishes the **vision, goals, and policy direction** for the next 20 years.
- **A clear road map for accomplishing shared goals.**
- Establish the **types of neighborhoods and districts** we want in the future.
- Provide an **implementation strategy**
- An essential step in a continuous process that is designed to be **flexible and adaptable to guide citizens** and decision-makers on how a community should grow over time.
- **Adoption: October 2024**
  - 31-member steering committee + 23 subcommittee meetings
  - 8083 comments across 99 engagement events



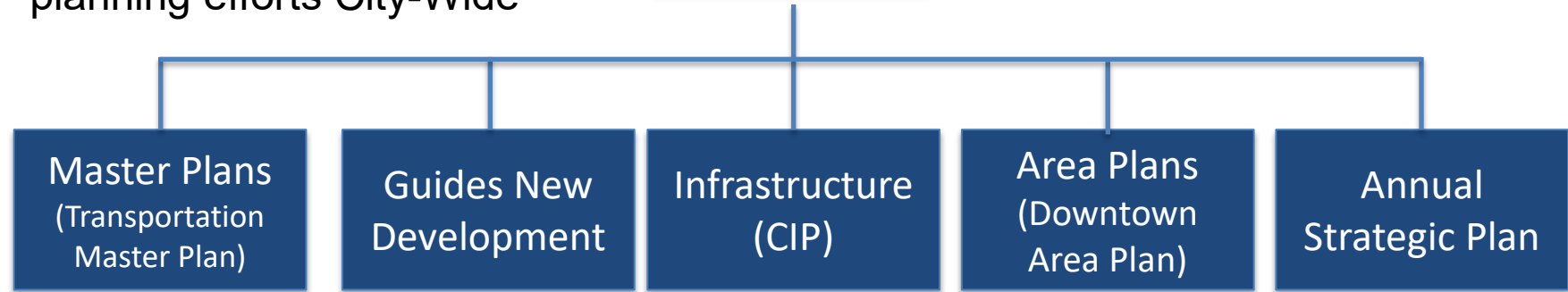
# Plan Relationship to City

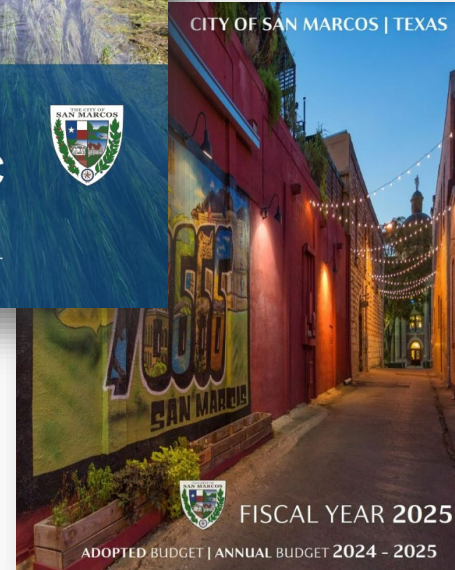

# CPOC Top Priorities

**TR-1.1**

Update the 2018 Transportation Plan (TMP) to be consistent with the Preferred Scenario Map and address current transportation issues.

# CPOC Top Priorities



## TR-1.1

Update the 2018 Transportation Plan (TMP) to be consistent with the Preferred Scenario Map and address current transportation issues.

### Committee Considerations

- TMP will shape transportation policy for existing and future residents
- Stress the importance of public transit and connections to regional transit partners
- Importance of evaluating pedestrian/bike crossings for safety improvements at key intersections and longer blocks

### Implementation Update

- Transportation Master Plan update in-progress



# CPOC Top Priorities

- LU-3.7** Create a tool to analyze the “fiscal sustainability”, defined as the long-term public cost obligations and fiscal productivity, of new development proposals.

## Committee Considerations

- Budgetary impacts of development on infrastructure, utility capacity/rates, and environmental costs
- Cost/benefit of development to the city’s fiscal health
- Education on long-term fiscal sustainability and return on investment

## Implementation Update

- Implementation will require consultant services to develop tool and conduct education with community and appointed/elected officials
- Collaborative effort with Finance and Economic Development department



# CPOC Top Priorities

## HN-4.3

Coordinate land use and transportation planning with proposed developments to ensure safe and convenient connections to sidewalk, bike lane, and transit networks from residential neighborhoods.

### Committee Considerations

- Key factor of safe and convenient connections is proximity to goods and services
- Importance of multi-modal connectivity to neighborhood centers

### Implementation Update

- In-progress updates to the Development Code, Transportation Master Plan, and Transit Route Study.



# CPOC Top Priorities

**HN-1.1** Update, review, and adopt a Housing Action Plan.

## Committee Considerations

- Importance of adopting a plan to address housing affordability challenges
- Emphasize the topics of:
  - Availability of diverse and adaptable housing
  - “Aging in Place”
  - Empowering incremental development

## Implementation Update

- Update and review of Draft Strategic Housing Action Plan is in-progress
- Will include updated data and opportunities for public input

# CPOC Top Priorities



## ECD- 2.1

Protect and promote land uses that support target industries, support diversification of the City's tax base, and enhance economic development by using tools such as intentional infrastructure planning, recruitment, and the land use entitlement process.

### Committee Considerations

- Implementation should include a balance of both retention of small businesses and talent alongside the attraction of new businesses and talent.

### Implementation Update

- Future update to the Economic Development Policy and explore economic development programs
- Explore method to track private investments and fiscal impacts to the City

# CPOC Top Priorities



## ENV-3.4

Encourage developers to implement green building practices, and conservation-style development.

### Committee Considerations

- Supports cluster/conservation style development types that preserve, enhance, or augment the greenbelt network
- Use of regulatory incentives for implementation
- Implementation of green building and sustainable site standards in city capital projects

### Implementation Update

- Development Code update to refine the Planning Area District to support cluster-development
- Draft Historic Preservation Plan encourages education surrounding the sustainability benefits of historic buildings
