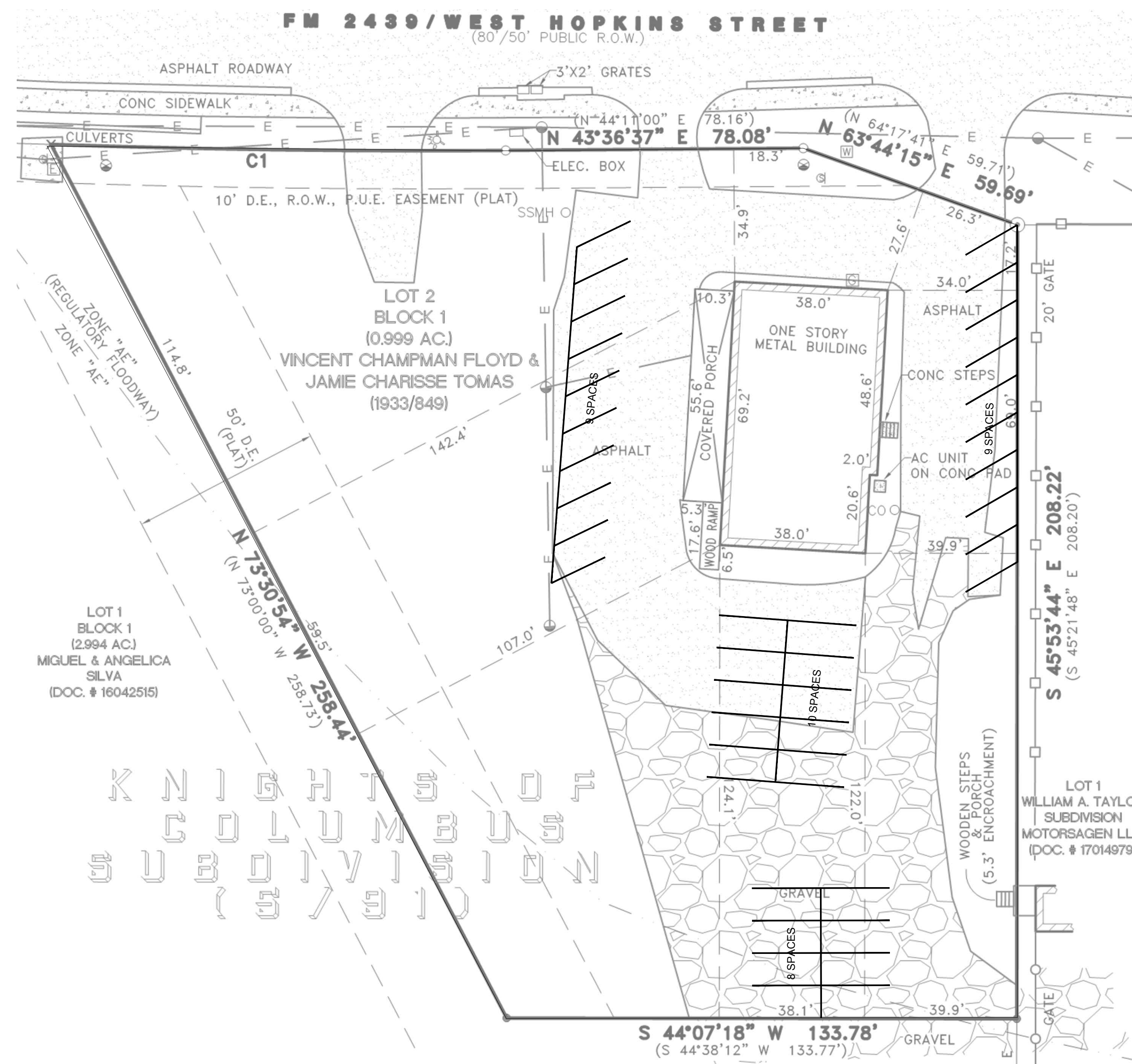

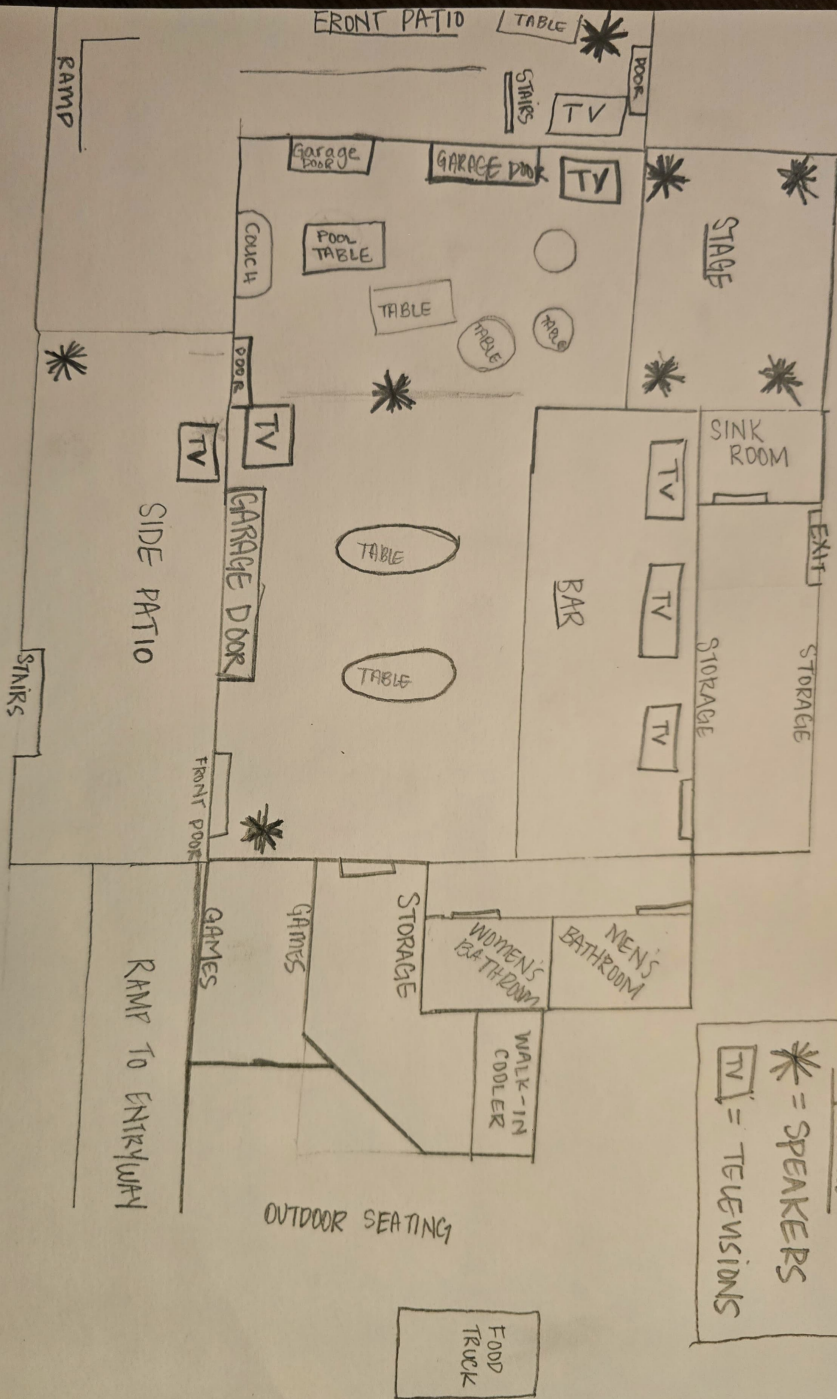


## Site Plan

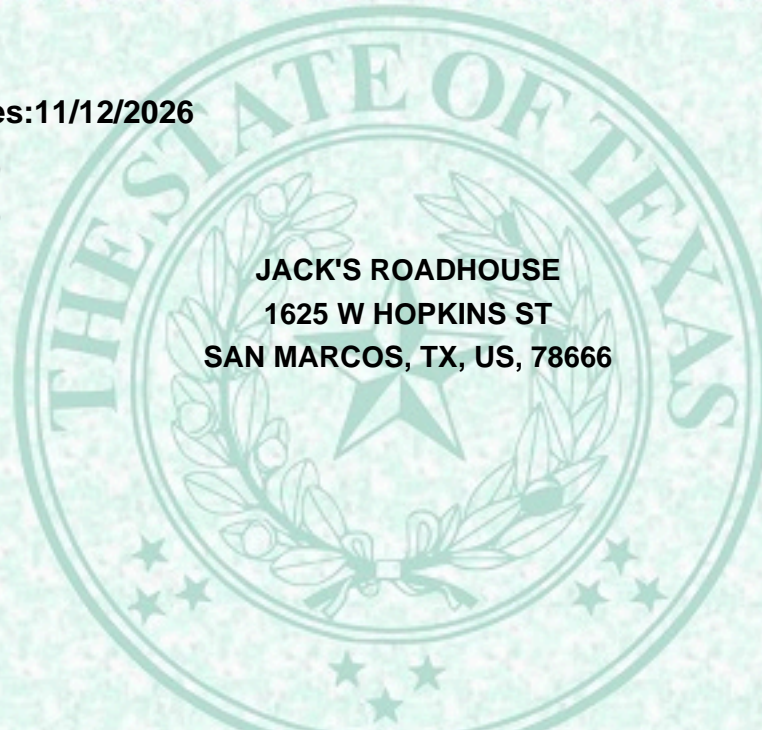
