Notification of Proposed Annexation by the City of San Marcos - AN-24-04 (La Cima PEC Substation Annexation)

Dear Public Entity Representative:

Under Local Government Code Chapter 43, cities are required to notify certain public entities of all proposed annexations. The San Marcos City Council is considering the following annexations that may affect your jurisdiction:

Annexation of approximately 7.913 +/- acre of land out of the John Williams Survey, Abstract No. 490, and the John Maximillion Jr. Survey, Abstract No. 299, generally located on the south side of Ranch Road 12, approximately 1,200 feet northwest of W Centerpoint Road.

All annexations are subject to notification, public hearings, and vote by City Council. The annexation schedule is as follows:

Ordinance 1st Reading (Public Hearing): August 5, 2024, at 6:00 p.m., City Council Chambers, City Hall, 630 E. Hopkins St., San Marcos. (This hearing is a hybrid of virtual and in-person meeting.)

Ordinance 2nd Reading: August 20, 2024, at 6:00 p.m., City Council Chambers, City Hall, 630 E. Hopkins St., San Marcos. (This hearing is a hybrid of virtual and in-person meeting.)


