		<p>approached the staff and spoke with the manager, Mr. Prasad Dalvi, and asked for the current occupancy load count. Mr. Dalvi advised that the occupant load was 230 and that they were only allowing patrons to enter as others exited. Mr. Dalvi and I proceeded up the stairs into the establishment, where we determined that the venue was over its approved occupancy limit. The interior was filled with patrons standing shoulder to shoulder, with little to no ability to move freely throughout the space. I advised Mr. Dalvi that we would need to clear the establishment and restart the occupancy count accurately, or we would be forced to shut down operations for the night. I also informed Mr. Dalvi that the path of egress and public way needed to remain clear and could not be obstructed by patrons waiting to enter. While standing across the street from the establishment, I observed the crowd outside growing substantially, creating a</p>

		<p>public safety hazard. The crowd began spilling into the street, causing vehicles to stop and maneuver around them. Patrons attempting to exit down the stairwell were unable to do so safely, as the crowd at ground level was blocking the exit path, creating a dangerous bottleneck. Given the totality of the circumstances, I determined that the safest course of action for both patrons and the public was to shut down the establishment for the remainder of the night. I advised Mr. Dalvi that both the upper and lower levels of the establishment were to be closed due to the following violations:</p> <p>Unsafe Conditions – IFC 114.1.1 Overcrowding – IFC 109.6 Obstruction of the Public Way – Municode Sec. 74.122 Blocked Path of Egress Crowd Spilling into the Street and Impeding Traffic</p> <p>Mr. Dalvi was understanding and compliant with the orders.</p> <p>Due to the growing crowd outside The</p>
