OVERVIEW

1. Summarize the program for which funding is being requested, the services it provides, and the clients it serves.

School Fuel provides weekend food support for hungry children in the SMCISD who come to school on Monday too hungry to learn. Each weekend of the school year a sack with 10 nutritious food items is sent home with students K-12 in every school in the District. The children are identified by school personnel and the food is distributed by school personnel. School Fuel is an all-volunteer organization that receives no governmental funds other than an HSAB grant from the City. In the 2025-2026 school year 1,400 children will be served.

COMMUNITY NEED AND JUSTIFICATION -15 POINTS

Evaluation: documentation and justification of the need for the program in the City of San Marcos.

Describe in detail the need for this program in San Marcos.

In the SMCISD 75% of the students enrolled qualify for the Federal Free/Reduced Lunch program. As a result, the District provides free breakfast and lunch for every student. However, weekend hunger is persistently a problem and hungry students are unable to learn on Monday. According to the US Census Bureau 27% of the population in San Marcos lives below the poverty level compared to all of Texas where the rate is 14%. If children are to achieve their academic potential, they must be able to work effectively at school on Mondays.

Studies show that children who face food insecurity continue to have problems into adulthood such as obesity, difficulty with interpersonal skills and health issues.

Hungry children can't learn. When children come to school on Monday having had little or nothing to eat over the weekend, they can't focus on school work. They go to the nurse complaining of stomach aches. They're lethargic, too. They cause disruptions in the classroom because they have trouble working cooperatively with peers. Teachers say these issues all take time away from learning not just for the hungry children but for the entire classroom. Food insecure children fall behind in elementary school and get further behind in middle school and effectively drop out in high school, though they may remain enrolled. Without an education overcoming poverty will be a very difficult challenge.

2. Has the need for this program been increasing in recent years?

The need continues to grow. In the 2025-2026 school year School Fuel will add 100 high school seniors to the 1,300 children already served by the program. Many of the students we serve live in generational poverty. School Fuel has added children to the program every year since 2013.

Increases in the cost of living places even more stress on families. According to the Bureau of Labor the cost of living has risen almost 6% in the last two years. And recent increases in the cost of groceries and other basic needs have further stressed poor families. Parents may be working more than one job which leaves children at home alone so all food provided children by School Fuel is shelf safe and individually packaged and easily opened by small hands.

We also anticipate that families will have more trouble learning about other support resources in the upcoming year since the elementary schools will no longer have a parent liaison. These individuals helped parents find needed resources and learn more about how to support a child's educational journey. Without this help, some families may have an even more difficult time providing adequate food for their children. There is also concern that some current aid to impoverished families may be decreased due to a cuts in federal and state budgets.

IMPLEMENTATION -15 POINTS

School Fuel has been serving hungry children in the SMCISD since 2013. Hundreds of volunteers come on most Thursdays to pack sacks and sometimes on Friday to deliver bins of food sacks to the schools. We have a permanent, free to us, location in the new SMCISD Administration Building. We have support from Ace Relocation Systems to help deliver and a cooperative purchasing program to buy food at discounted prices in cooperation with similar programs across Texas. We have support from civic organizations and churches who not only send volunteers but also provide financial support.

2. What specific, measurable outcomes or results do you hope to achieve with this program?

The long term goal is to enable food insecure children to achieve their academic potential so that they will be able to overcome poverty. This is a goal that we share with the SMCISD and with whom we work cooperatively. School Fuel's goal is to be able to provide weekend food support for the hungry children who without help, routinely come to school too hungry to learn.

The children are identified by school personnel—cafeteria workers, teachers, nurses, parent liaisons. School Fuel provides weekend food for these children up to a maximum number set by the Board of Directors based on need and available funding. In the 2025-2026 school year we expect to provide for about 1,400 each week. According to last year's work with District personnel, that will support those students who most need the help. Should that number increase, the Board of Directors will evaluate the request and make an adjustment if financially feasible.

Our measurement is being able to meet the need identified by the District. The District measures the success of students. We know from teachers and other school personnel that the children who receive School Fuel make fewer trips to the nurse, have better attendance, and cause fewer disruptions in the classroom when they are receiving weekend food support than they did when they were not.

Children should not go hungry. And all of us understand how unproductive we are when we are hungry. Will every child who receives School Fuel be able to overcome poverty? Maybe not but without help a much larger number are likely to continue to live in poverty in adulthood. Feeding hungry children in San Marcos is the right thing to do.

3. If funding is not available at the requested amount, what is the minimum Human Services Grant funding needed to be able to run this program?

Raising funds in San Marcos is a challenge especially when you need \$330,900 to be able to provide for 1,400 hungry students (and this budget DOES NOT include funds for any employees or a facility). School Fuel doesn't start any child on the program until funds for that individual are on hand or committed. Receiving a grant of less than the \$44,000 requested would mean trying to find some alternative source of funding. However, the School Fuel Board of Directors is committed to achieving the mission.

A City that has fewer of its residents living in poverty is a better City. We are hopeful that the City of San Marcos will want to continue to invest about \$250 a year in 1,400 children to help make that possible.

- 1. Programs can provide value by deeply impacting the lives of a few, with effects that may ripple through generations, or by providing smaller but meaningful impact to a larger group. Describe in detail the impact this program will have on the identified need and on San Marcos residents.

Children who go hungry on weekends often fall behind in elementary school and have difficulty catching up. Any child who comes to school hungry will have trouble concentrating on the work at hand. If weekend food can enable a child to keep up, they will be able to reach their academic potential which is imperative if poverty is to be overcome. When a child is successful at school they are far more likely to be successful as adults which not only benefits that individual but also benefits the entire community. Since San Marcos has more than 27% of its population living in poverty, making an investment of about \$250 a year in a child seems a wise decision.

2. Briefly describe other funding sources, volunteers, or in-kind donations that will be used with this program.

School Fuel has at least 30 volunteers every week amounting to more than a thousand every year. Civic organizations, churches, and local businesses not only send volunteers but also support School Fuel financially. Many local residents support School Fuel. Other than a grant from the City of San Marcos, School Fuel receives no government funding. We received grams from the Anderson Foundation, Najim Foundation, Montandon Foundation and Baptist Health Foundation, and Texas Baptist Hunger Fund.

Ace Relocation Systems takes the food from our facility to the schools on Fridays as an in-kind contribution. The SMCISD provides our facility free of charge to us.

In the 2025-26 school year, School Fuel will spend only about \$10,900 to provide \$320,000 worth of food to 1,400 children. Those expenses include insurance, printing and postage, tax return preparation and fundraising. The total is less than 4% overhead and is possible only because the organization is all volunteer and has a facility provided at no cost. Not many non-profits can say the same thing.

3. How many total annual unduplicated direct clients is this program expected to serve? What percentage will be San Marcos residents?

1,400 children will be served. 100% are enrolled in the SMCISD.

Every board member has an active role in the organization because School Fuel has no employees. One board member handles the website and all media. The secretary handles the email account and all correspondence. Another board member meets the food delivery truck and receives the food. One coordinates the delivery of the food to the schools. Another board member receives contributions, makes deposits and seeks grant funding. Another board member chairs the Fun Run event and our president coordinates with the schools. All help with packing, fundraising and other tasks.

2. Briefly describe the number and role of volunteers in the program or agency's operation.

Food is packed most Thursday evenings in two shifts. On average there are about 30 volunteers in total including board members for 40 packing nights during the year. Volunteers prepare the assembly lines, pack the food, take out the recycle materials and set up for the next week. On occasion volunteers also deliver bins of food to the schools. Since there is no paid staff, volunteers, including the Board, do every task required to provide hungry children with weekend food. In total volunteers have given more than 3,500 hours a year to School Fuel.

School Fuel has provided weekend food to hungry SMCISD students for 12 years, 2013-2025.

Yes. The School Fuel facility is located in the SMCISD Administration Building at 1331 SH 123. It is separate from the District's offices, however.

3. Describe how this funding will create an increase in services or an increase in the number of people served. (10 points if creates an increase)

School Fuel will add 100 high school seniors to the program in the fall of 2025 bringing the total high school number to 400. This enables us to continue provide for hungry students in every grade (except Pre-K which has its own program) at every school in the District as well as adding high school seniors. The cost of providing for these 400 high school students is about \$100,000 per year (\$250 per student).

PROGRAM STATUS

Please provide a written description of actions taken this period and how they helped achieve your program goals.

School Fuel delivered a sack of food to about 1,200 hungry children in the SMCISD every weekend of the school year and also provided an additional sack with peanut butter, crackers and a Hershey Bar at Christmas, Spring Break and the end of the school year. In total more than 44,500 sacks were distributed to students who otherwise had little or nothing to eat on weekends.

Teachers of these children report that the food makes a difference in these children's abilities and behavior on Monday. They make fewer trips to the nurse, are more attentive and cause fewer class disruptions and in general are better able to participate in learning activities. Kids who have weekend food support are less likely to fall behind.

The long term goal is to enable food insecure children to succeed at school. School Fuel is able to provide weekend support with the help of at least 1,000 volunteers who come each week to assemble the packing line and fill the sacks. In the high school, the sacks are filled by students supervised by teachers and administrative personnel.

Hungry children can't learn and adults without an education will have difficulty overcoming poverty. Our program aims to improve the San Marcos community by helping to reduce poverty.

Roll filled bins into pickup area grouping by school and delivery route.

Take recycled cardboard to outside dumpster.

Bring food from storage area and prepare assembly line for the following week.

Delivery of bins to ten schools will begin at 8:00 on Friday or the last day of the school week. If Ace is making the delivery bins are to be lined up according to list posted on inside of the packing room door. The responsible board member is to open the building at 7:45 am and be there to receive bins as they return.

If Ace is not making the delivery the volunteers will be contacted early in the week. The responsible board member will assist in loading the bins into volunteer vehicles and is to be on hand to receive the bins when the volunteers return them.

My purpose in writing this letter is two-fold. First, I would like to thank the City of San Marcos for providing grant monies to fund the School Fuel program over the last several years. Additionally, I am writing to encourage continued support through adequate funding for this vital service to our community.

Childhood hunger is a significant problem in America with approximately fourteen million children facing food insecurity. Although a national concern, we do not need to look beyond the boundaries of our city to see the impact of hunger on the children attending our schools.

Children facing hunger are at a higher risk for health issues and delayed physical development. Inadequate nutrition can significantly affect cognitive development. Hungry children often have difficulty concentrating in school and may face learning difficulties. Overall attendance and mental health are additional negative consequences.

The School Fuel feeding program positively mitigates these factors. By providing access to meals over the weekend, students are able to return to school with improved academic performance and higher attendance rates. It ensures that all students regardless of familial backgrounds have access to healthy meals.

Your generous award of \$44,000 last year allowed for an increase in the number of students receiving services. The goal for September is to include one hundred seniors to the program enabling students in grades K-12 to benefit from access to weekend meals. Our request for this next funding cycle is to secure renewal funding at the existing level or perhaps increased funding if available.
