1. Consider approval of Resolution 2025-79R, authorizing the naming of the small room, large room, and arts and crafts room in the Dunbar Recreation Center as the Marshall Room, the Ola Lee Coleman Room, and the Harvey Miller Room, respectively, as well as honoring a group of African American women known as the "First Five" in the lobby area; authorizing the City Manager, or her designee, to install any signs and recognition plaques reflecting the new room names; and declaring an effective date.
2. Consider approval of Resolution 2025-80R, approving a contract with T. F. Harper in the amount of \$238,130.45, through the Texas Interlocal Purchasing System (TIPS), replacing the previously approved Buyboard Cooperative Purchasing Program contract, for improvements to Swift Memorial Park that include replacing the engineered wood fiber material around the playscape equipment with padded play turf, adding ADA compliant

sidewalks for greater connectivity, two new picnic tables, resurfacing the existing basketball court, and installing a bottle fill water fountain; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.

3. Consider approval of Resolution 2025-81R, approving a contract with T. F. Harper in the amount of \$305,428.29, through the Texas Interlocal Purchasing System (TIPS), replacing the previously approved Buyboard Cooperative Purchasing Program contract, for improvements to the Victory Gardens Park that include replacing the engineered wood fiber playground material with padded play turf, adding shade structures to the existing playground equipment, making ADA enhancements to the parking lot and sidewalks, resurfacing the existing basketball court, and installing a bottle fill water fountain; authorizing the City Manager, or her designee, to execute the contract on behalf of the city; and declaring an effective date.
4. Consider approval of Resolution 2025-82R, approving a change in service to the Enterprise Security System contract with Mobile Communications America, Inc., to increase the contract amount to \$185,850.00 for fiscal year 2026 and \$210,000.00 for fiscal year 2027 for access control systems and facility security cameras; authorizing the City Manager, or her designee, to execute the necessary documents to implement the change in service on behalf of the city; and declaring an effective date.
