OVERVIEW

1. What is the agency's or organization's mission? The mission of Nosotros La Gente (NLG) is to supply money, goods, or services to the poor and other cultural or historical activities. Nosotros La Gente is a philanthropic organization that focuses on the immediate needs of people who are facing an economic problem.
2. Briefly summarize the program for which funding is being requested and the services it provides. These funds combined with our contributions will be used to assist families residing in the San Marcos CISD boundary with Rent and Utility Expenses. Funds may also be used to assist families with Funeral or Medical expenses.

1. Describe in detail the need for this program in San Marcos. For over 20 years Nosotros La Gente has been able to provide Hays County residents with Funeral, Rent, Utility and Medical Assistance. Because the source of these funds comes from the county, we are unable to assist residents who reside outside of Hays County but reside in the San Marcos CISD boundary.
2. Has the need for this program been increasing in recent years? These funds combined with our contribution will be used to assist families who reside outside of Hays County but reside in the San Marcos CISD boundary. The number of requests for assistance has been increasing in the past few years especially in the areas of Rent and Utility Assistance.
3. Client Information

School supplies include Pencils, Ballpoint pens, Markers/crayons/colored pencils, Highlighters, Erasers, Notebooks, Index cards, Loose-leaf binder paper, Graph paper, Folders, Binders, Clear tape, Glue stick, Water bottle, Lunchbox, Backpack, Pencil case/pouch, Gym bag, Elastic book covers (or repurpose paper grocery bags to cover books for a low-cost option), Computer and/or tablet, Printer (don't forget ink cartridges!), Calculator, Pencil sharpener, Scissors, Ruler, Clothing/shoes (School uniforms or dress-code-adherent attire, Gym clothes, Shoes and/or athletic-style sneakers, Socks and underwear, Winter coat, Winter hat, Gloves or mittens. The NLG Community Assistance Program meets the need to provide Rent and Utility Assistance.
2. Discuss the amount of overhead compared to program costs. There are no overhead costs associated with this program.
3. Provide a brief description of other funding sources, volunteers, or in-kind donations that are expected to be used with this program. The organization plans to send letters to potential donors. Grant applications will be submitted to Wal-Mart, and H.E.B. The organization will also be looking at holding fundraisers (i.e., plate sales).
4. What has your organization done in the past two years to raise different funding for this program? During the past two years the organization has mailed letters to potential donors and has submitted grant applications to Wal-Mart and H.E.B.

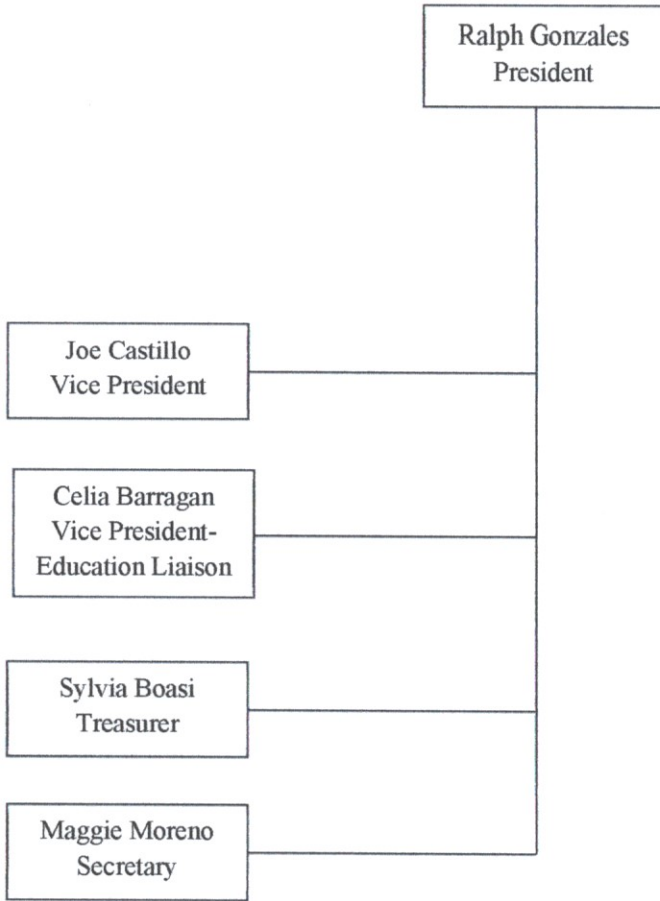

Due to the fact that I was the only one supporting our little family, quality time was not always the option. I was working a full-time job and come the beginning of a new school year and the early part of fall, I would have to take a second job just to be able to provide new school clothes, shoes and winter clothing for my child. This would take my time away from home, having to have my child care for himself, I alone couldn't afford childcare, but it was all we could do to survive. My name is Victoria Luna and I am the Parent Liaison for Bowie Elementary. Bowie Elementary is a Title I school with 74.79% of students who are economically disadvantaged. That is a reality here in our community and shoes are a visible sign of a low income family. Childhood is supposed to be a magical, carefree time. But kids can suffer excruciating stigma, bullying, and ridicule. All for lack of decent shoes. Families are struggling, and with the changing cold weather students are cold coming to school without jackets or choosing to stay home because they don't have a jacket. The simple gift of a pair of shoes or jacket can be a new lease on life for a child in need.

I am so GRATEFUL for Nosotros La Gente! They make a DIFFERENCE for a child in need! When we give shoes and jackets to a child we give so many other things such as Hope, Dignity, and Joy. Research has shown that when students receive new shoes, there is a 75% increase in physical activity, a 46% increase in student attendance, a 62% improvement on student behavior, and a 87% increase in self-esteem. This allows our students to reach their maximum potential.

The gratitude on the children's faces is priceless. They are so grateful when they receive their shoes. The smaller ones are ready to tell me "Ms. Luna, look at me run!" They are so excited!

I hope this organization continues for a very long time! Our community needs their support! Our students need this help in order to have a successful educational experience.
