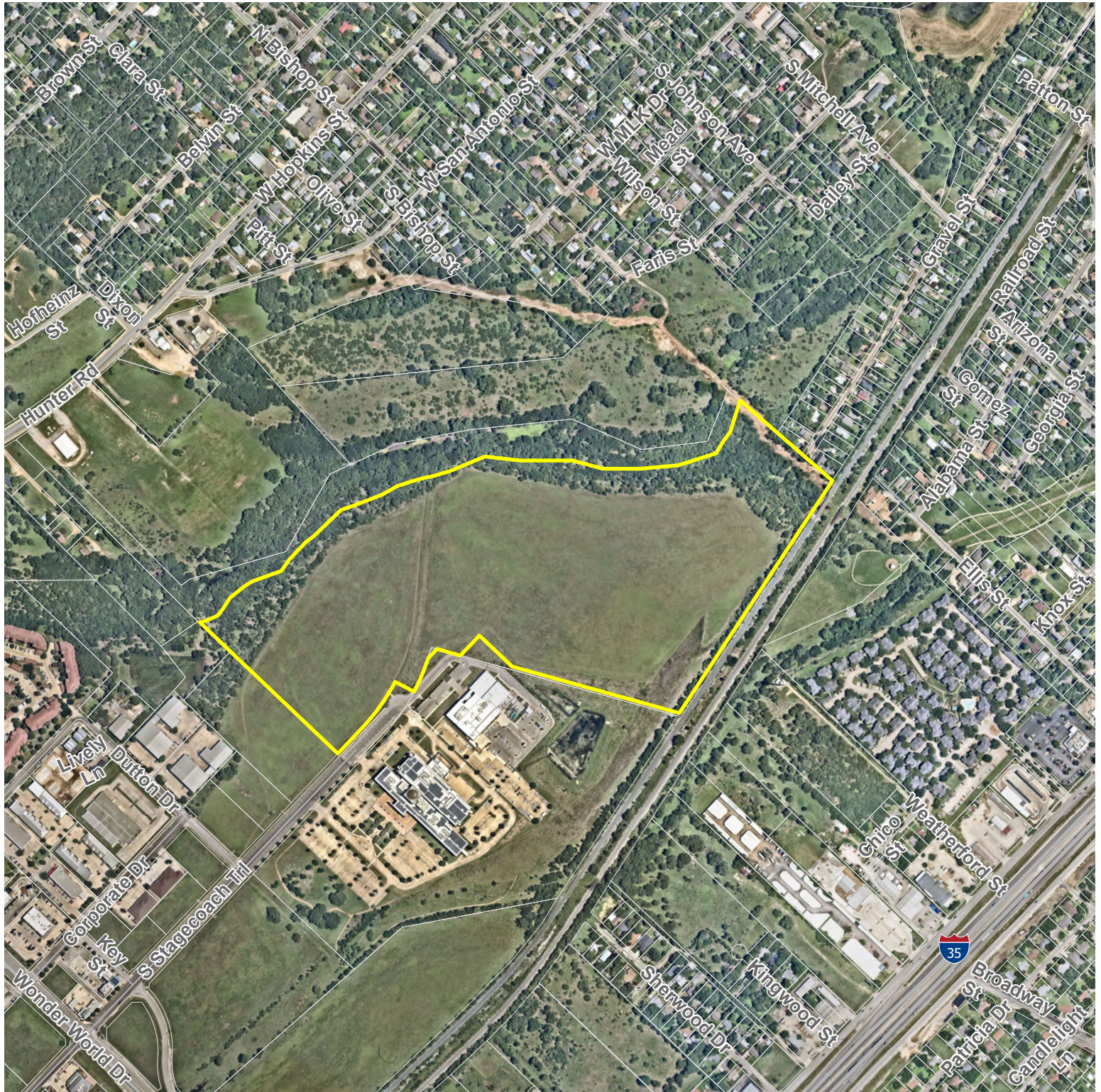


South End S Stagecoach Trail CD-4 800BLK S Stagecoach Trail

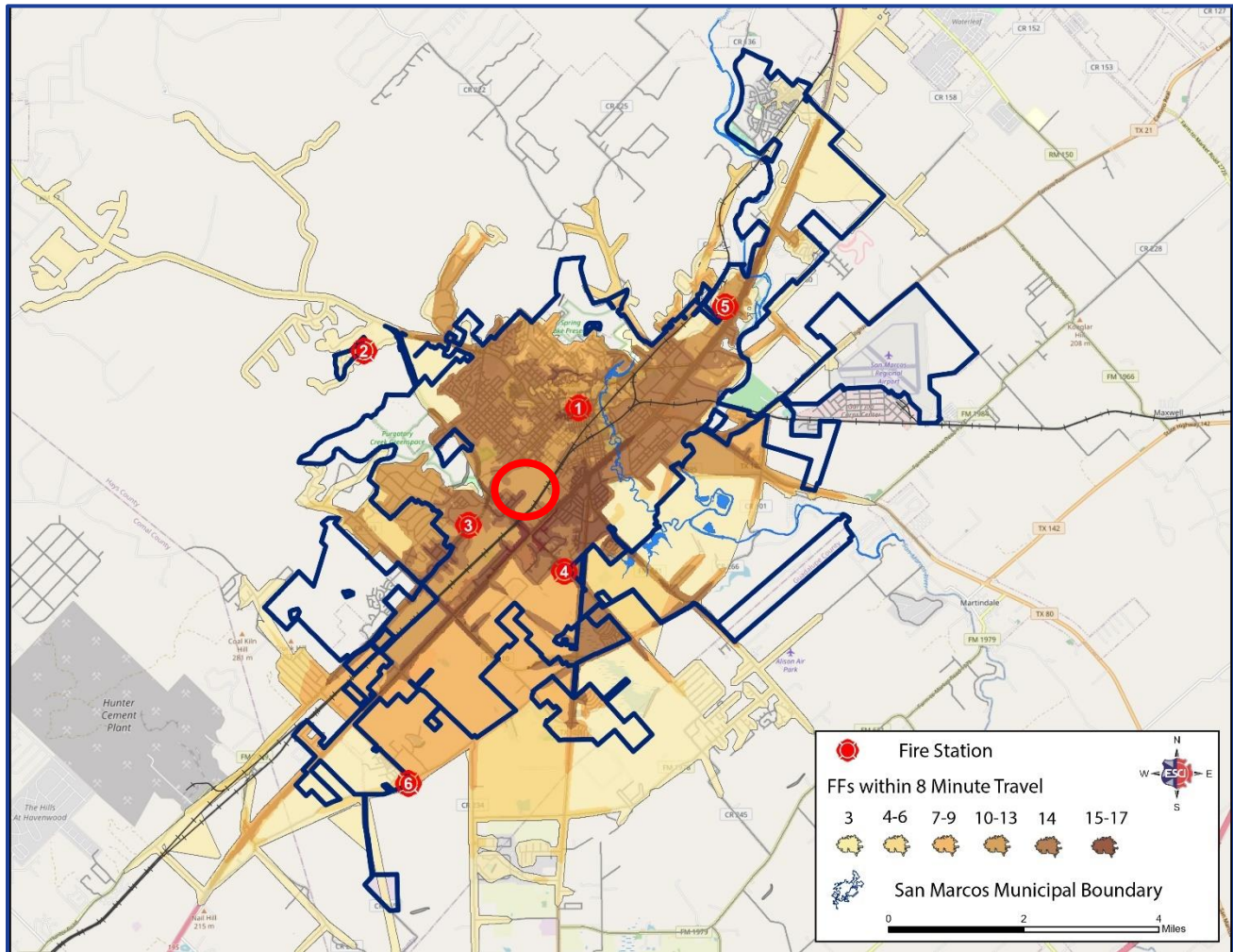

Six fire stations with Station 2 relocated to Centerpoint, and Station 6 at Old Bastrop west of Posey with minimum staffing of 20 personnel.

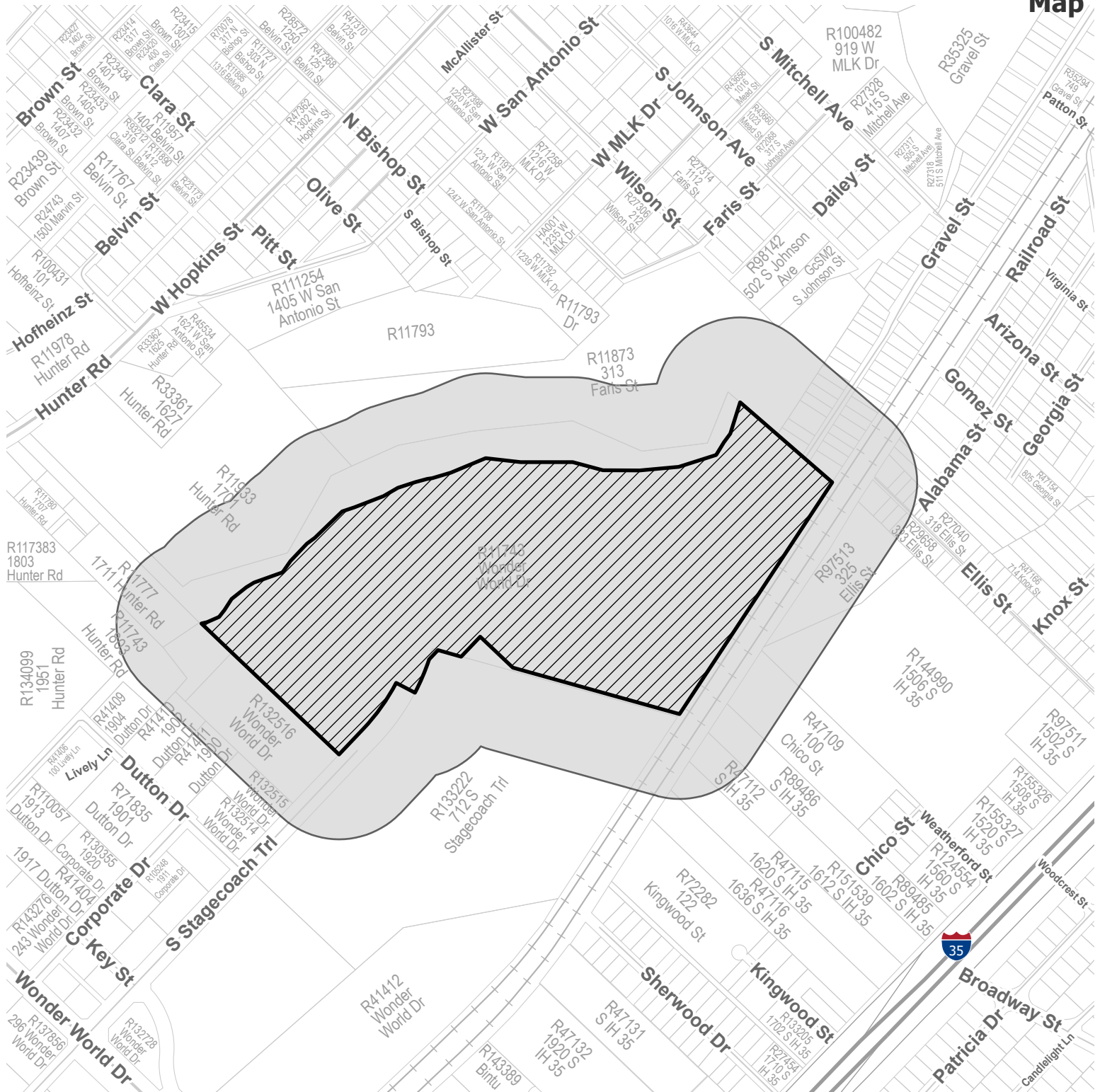





ZC-24-10 APPROXIMATE LOCATION
