Aerial Map



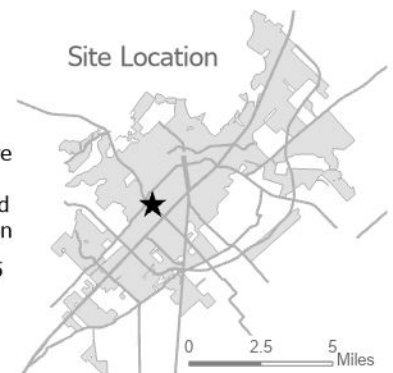

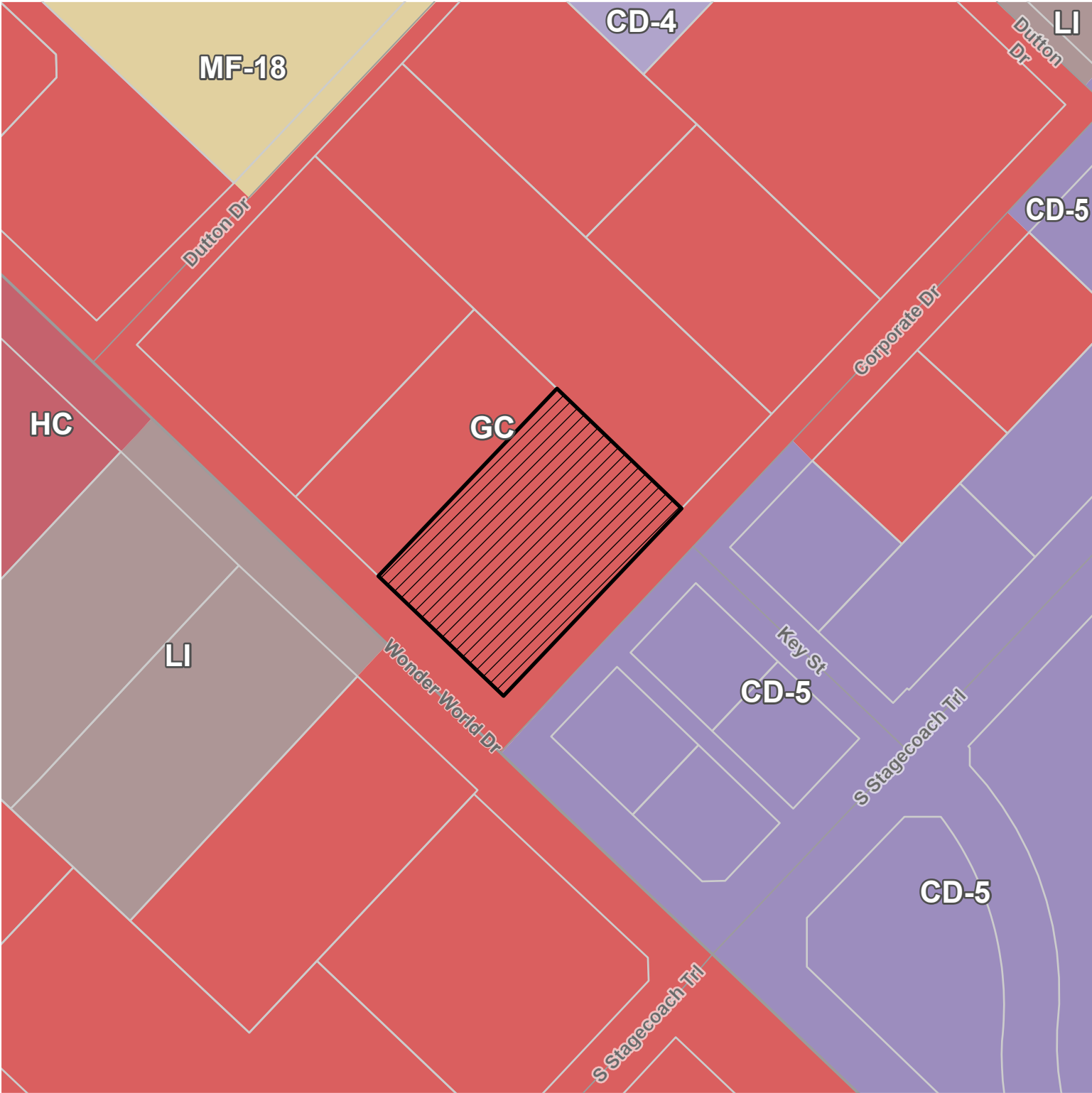

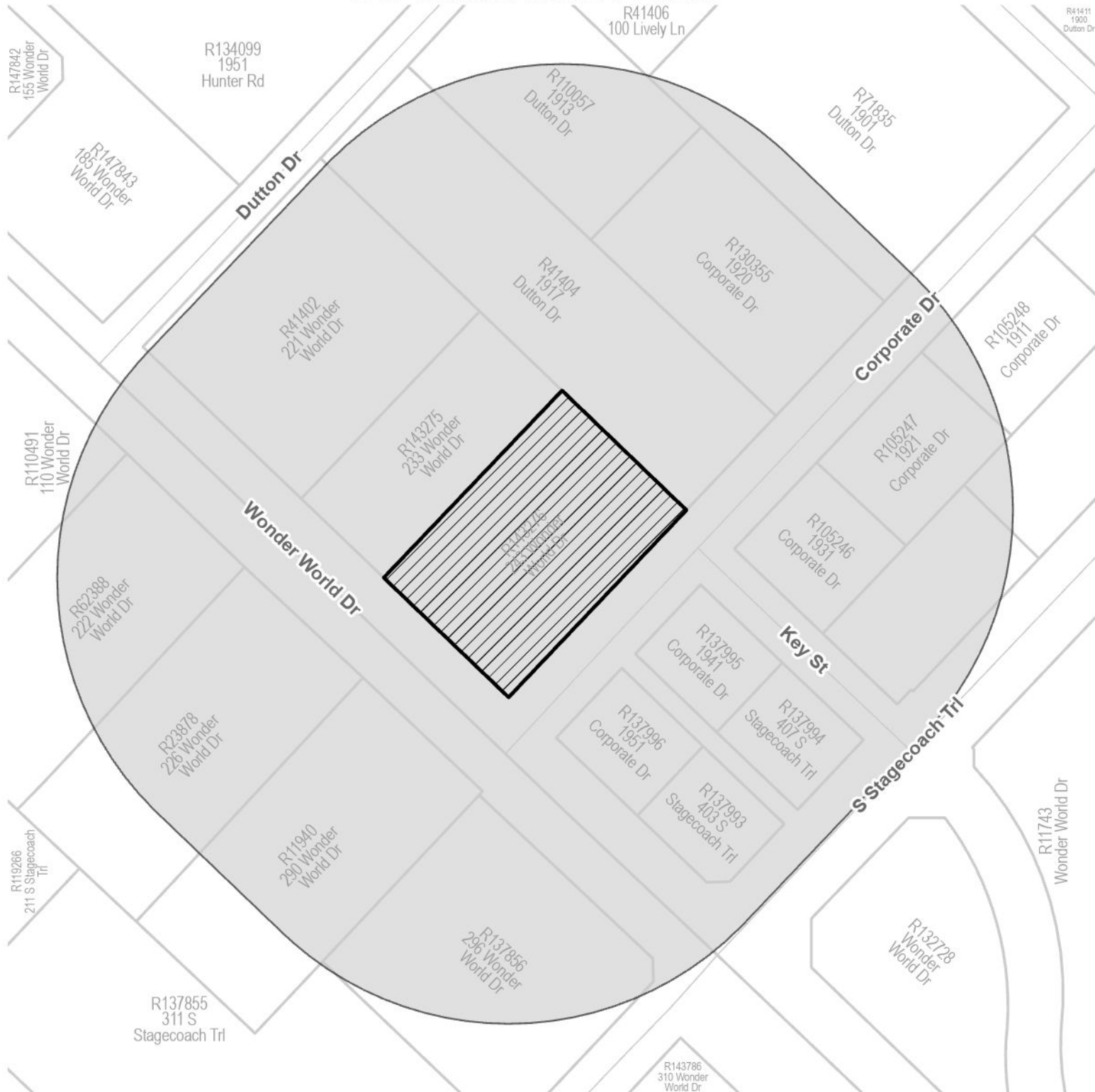

Notification Map



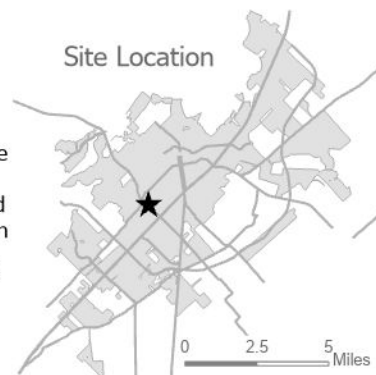
