NO data centers in San Marcos. The sole benefit is investment. The what extent to which this investment stays within the community is uncertain. Investors can always leave. Alternatively, there could be an agglomeration effect, wherein San Marcos and the county gain an abundance of data centers, placing even greater strain on our natural resources. Additionally, data centers are not associated with quality job creation. These facilities produce very few jobs. However, the environmental degradation will stay. In high humidity and hot climates, the air will carry higher quantities of pollutants. Water remains a concern.
Water is life and water conservation comes before development. My family does NOT want to see data centers in our community. I also do NOT want to see law enforcement training expenses increase for anything unless they're related to de-escalation, domestic and sexual assault response training, mental
more sidewalks! i've seen families walking on the street along CM Allen on their way to the river or park; not safe at all for families with strollers to be on the street.
Increased public safety for cyclists and pedestrians. Bike lanes and sidewalks; from Moore St. to Old Ranch Rd where the San Marcos Cemetery is located needs a bike lane and sidewalk. I'm against the data centers being built, I think San Marcos and Central TX needs to protections put in place for our water supply and our rivers. I have seen San Marcos go through many transformations over the last 40 years. First and foremost, the City of San Marcos should prioritize (1) protection of our most valuable resource - our water: the aquifer, the river, and controlled access to both. Charge vacant lot fees to incentivize infill development, increase housing stock

Change/Clarify policy about process for developers being denied or failing to receive approval at p and z or Council. What is the restart time to come back, what does substantially different mean, etc.
