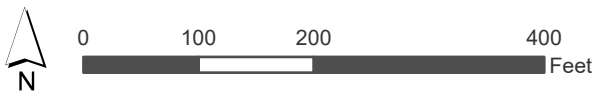

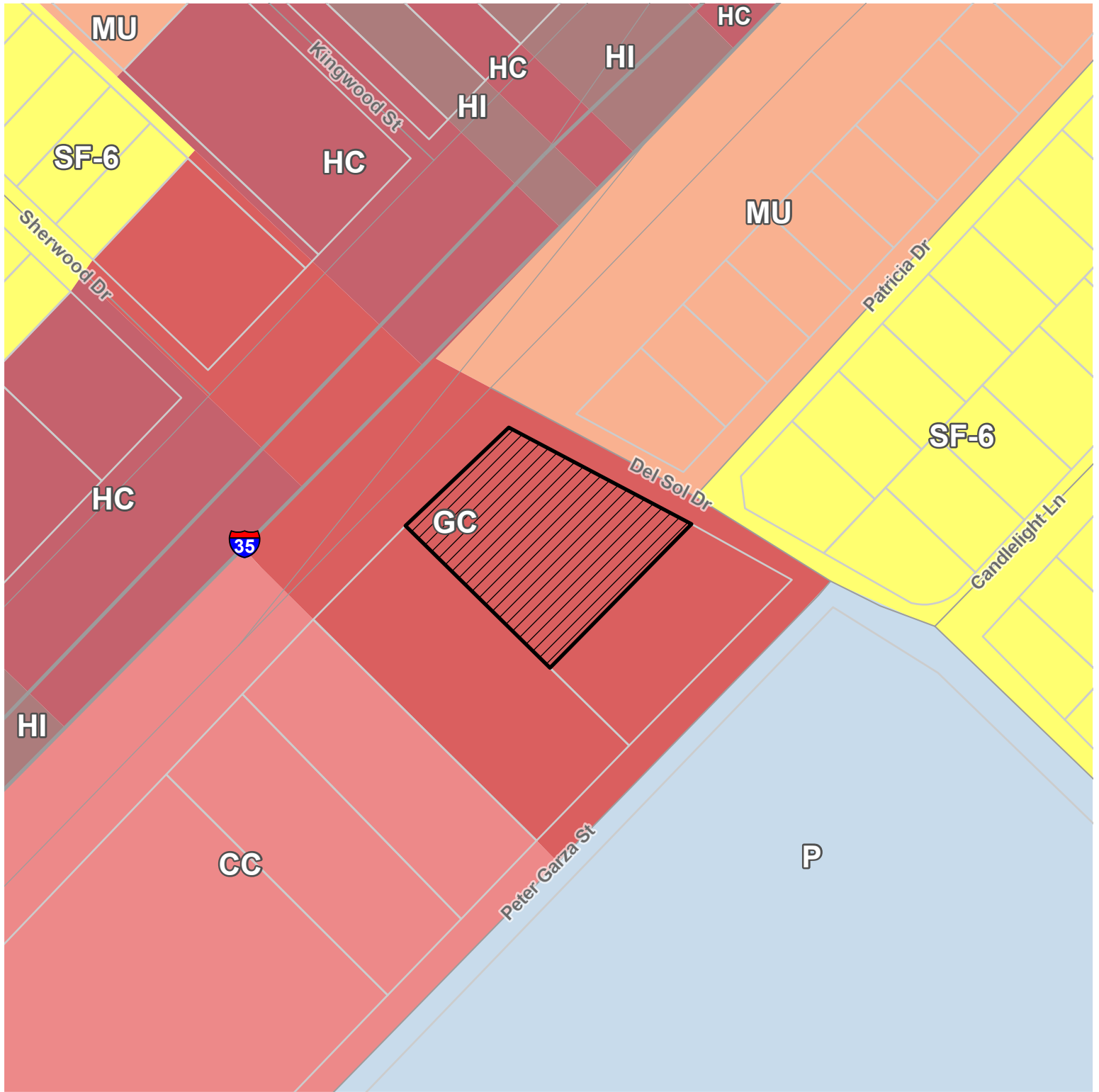

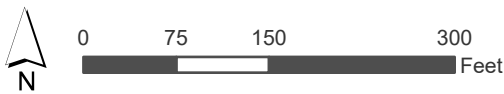
Site Location

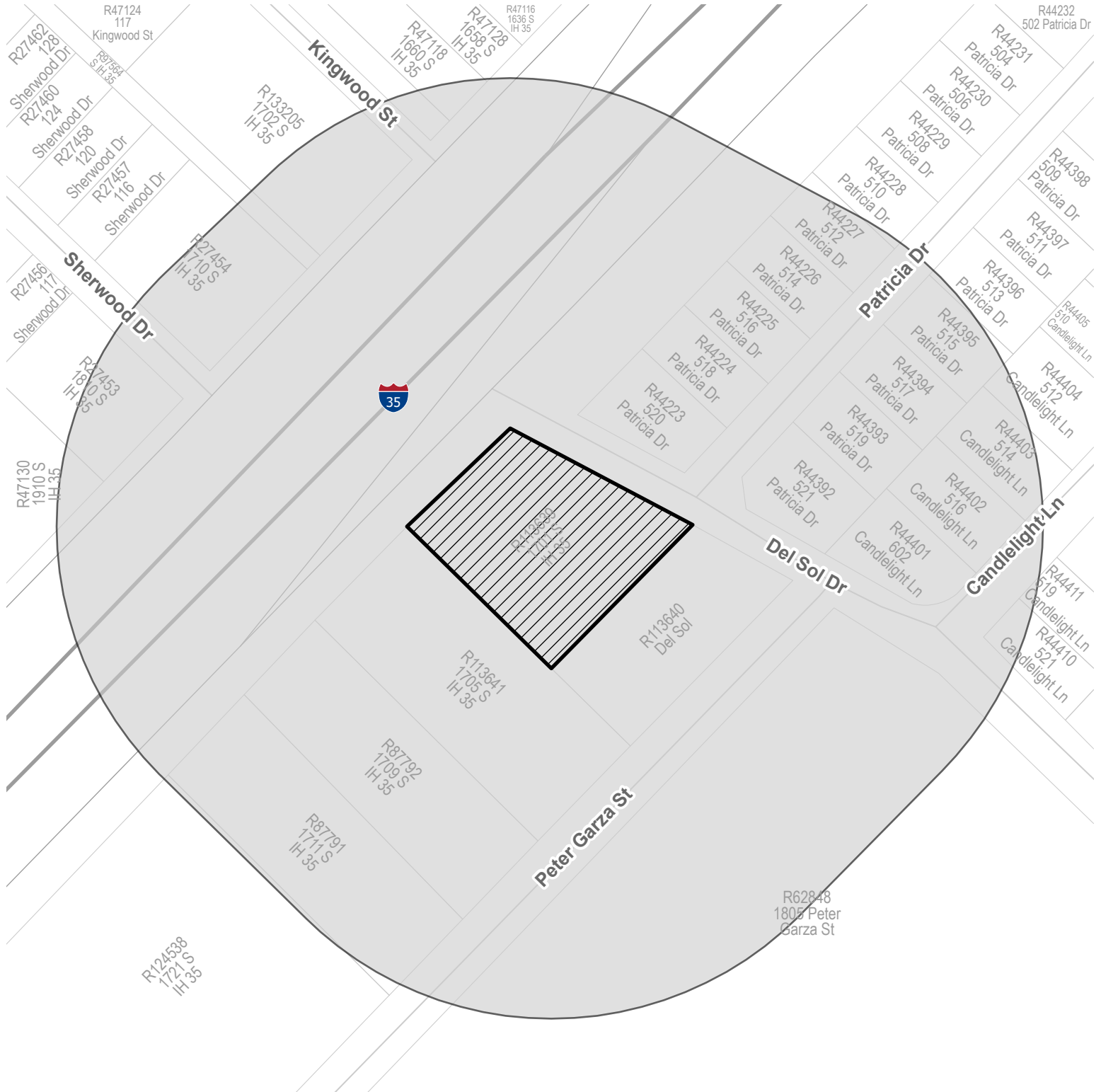

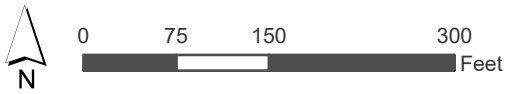
