- 6. Consider approval of Ordinance 2024-12, on the second of two readings, amending the Official Zoning Map of the City in Case No. ZC-24-02, by rezoning approximately 2.133 acres of land out of the Barnette O. Kane survey, Abstract No. 281, Hays County, Texas, generally located at the northeast corner of the South Old Bastrop Highway and Redwood Road intersection, from character District-5 "CD-5" District to Commercial "CM" District, or, subject to consent of the owner, another less intense zoning district classification; including procedural provisions; and providing an effective date.
- 7. Consider approval of Resolution 2024-34R, approving a full release and a partial release of an easement that releases all and a portion of Electric Easements in the Replat of Wide-Lite Unit 1 Subdivision development, located in the vicinity of Wonder World Drive, between IH-35 and Stagecoach Trail, subject to replacement easements being dedicated to the City; authorizing the City Manager, or her designee, to execute the full release of easement and partial release of easement on behalf of the city; and declaring an effective date.

Consider approval of Resolution 2024-35R, approving an agreement with Rush Truck Center, through the Texas Buyboard Purchasing Cooperative for the purchase and delivery of one Peterbilt Chassis with 548 Dump Body for use by the city's Water and Wastewater Divisions, in the amount of \$175,374.73; authorizing the City Manager, or her designee, to execute the agreement on behalf of the city; and declaring an effective date.
