- 4. Ordinance 2016-03, on the second of two readings, creating a designated permit area under Section 82.189 of the San Marcos City Code that allows parking by permit only on both sides of the 600 Conway Drive; amending the traffic register to reflect such designated permit area.

Resolution 2016-23R, approving the first amendment of the Interlocal Cooperation Agreement between the City of San Marcos and Dallas County Schools D/B/A Texserve to administer the Automated School Bus Stop Arm Enforcement Program; increasing payments to the City from 12.5 percent to 20 percent of funds collected from citations issued under the program.

Discussion regarding the possible amendment to Chapter 90, Articles 1, 2, 3,5, and 6 of the San Marcos City Code governing Vehicles for Hire by modifying application requirements, requiring inspection and parking areas for private systems and shuttles. and creating operational permits; further amending said Chapter 90 bv amending Article 6 that establishes regulations for Ground Transportation Services, and provide direction to Staff.

The Council discussed and asked questions regarding items on the agenda for March 1, 2016 Regular City Council Meeting. The Council requested a redlined copy of the Guiding Principles for the 2016 City of San Marcos Federal Program Activities and insert a change to the transportation to state "...regional commuter rail, including but not limited to the Lone Star Rail Project." Council also provided direction to push the Chapter 90 Vehicles for Hire item to April 1 and to bring forward the amendment allowing Transportation Network Companies the use of the Taxi Stand on March 15, 2016. Council provided direction to Staff to not post the proposed mobility workshop for Tuesday, March 1 and to present the presentation during Item #9 instead.
