Comment received by City staff: From: Pastor Todd Salmi, resident, Bishop Street

There is a desperate need for a pedestrian sidewalk on Bishop Street between Hopkins/Hunter and Prospect Road. It is only a matter of time until a serious accident or fatality will occur along this street of road. Many people walk this road for work, education, public transportation, and to access the City center. Portions of this section of Bishop have no place but the street for pedestrians to walk; there is limited visibility for eastbound travelers which is made worse in the rain and at night. This section contains a marked bus stop, but there is no sidewalk for ADA accessibility. FROM: Rudy Rodriguez (Victory Gardens Neighborhood Representative)

- Supports continued improvements / expansions to the existing Senior Citizens Center to address
 the needs of the growing senior population. Although the CDBG program is currently expanding
 the size of the Senior Citizens Center, there will be a need for future expansion of the current
 center or construction of additional centers. Mr. Rodriguez recommends the city host an Open
 House when the improvements are completed to bring awareness of the services and the need.
- Requests that lighting be installed at the newly improved Willow Springs Park and walking trail. He reported that area residents are utilizing the park/trail, but are concerned about walking there after dark.
- Supports improvements needed at the HEB Park. Although the park is located in a flood prone area, the city is planning for major drainage improvements to the Willow Springs drainage channels possibly reducing the amount of the park in the floodway, which he hopes will allow for future park development.
- Recommends that a covered bus stop be added to the Camacho Street bus stop, where the bus stop sign was damaged and removed.

FROM: Garrie Borden, Hays Caldwell Women's Center

Supports continued funding of the Hays-Caldwell Women's Center/Shelter due to the growing need, as there has been a 17% increase in services needed since last year.
