








AC-24-02 (San Marcos Courtyard Villas Block Perimeter) Hold a public hearing and consider a request by ViewPoint Engineering, on behalf of John Haberer, for an Alternative Compliance to the requirements in Section 3.6.2.1. (Block Perimeter) of the Land Development Code to allow the block perimeter within a CD-5 development to be greater than 2,000 feet, located at 1799 HWY 123. (K. Buck)

The San Marcos Planning and Zoning Commission will consider the above request at an upcoming public hearing to obtain citizen comments and will either approve, approve with conditions, or deny the request.
