“CC” Community Commercial to “HC” Heavy Commercial
400 Block Riverway Avenue/Blanco Riverwalk CC to HC Zoning Change**

ZC-20-26 (400 BLOCK RIVERWAY AVENUE/BLANCO RIVERWALK CC TO HC ZONING CHANGE) Hold a public hearing and consider a request by Robert W. McDonald, on behalf of BR2020 Land Bank LLC, for a zoning change from “CC” Community Commercial to “HC” Heavy Commercial, or, subject to consent of the owner, another less intense zoning district classification, for approximately 15.2331 acres out of Lot 1, Block F, of the Final Plat of the Blanco Riverwalk Subdivision, located in the 400 Block of Riverway Avenue.

The San Marcos Planning and Zoning Commission will consider the above request at an upcoming public hearing to obtain citizen comments and will either approve or deny the request. This recommendation will be forwarded to the San Marcos City Council. Before making a final decision, the Council will hold a public hearing to obtain citizen comments.
