I. Call To Order

With a quorum present, the special meeting of the San Marcos City Council was called to order by Mayor Hughson at 6:00 p.m. Monday, November 18, 2019 in the City Council Chambers, 630 E. Hopkins, San Marcos, Texas 78666.

II. Roll Call

Mayor Pro Tem Prewitt was present on the dais until Item #2. Council Member Baker joined the dais following completion of Item #2.

1. Consider approval of Ordinance 2019-42, on first and final reading, canvassing returns and declaring results of the General Election, held on November 5, 2019, for the purpose of electing City Council Member, Place One and City Council Member, Place Two; declaring an emergency creating the need to adopt this Ordinance with only one reading; and providing an effective date.

A motion was made by Mayor Pro Tem Prewitt, seconded by Council Member Derrick, that this Ordinance be approved. The motion carried by the following vote:

2. Issue Certificate of Election to City Council Member, Place 1 and City Council Member, Place 2; and administer Oath of Office.

Mayor Hughson issued the Certificates of Election to Council Member Maxfield Baker, Place 1 and Council Member Saul Gonzales, Place 2. Following issuance of the Certificates, Mr. Richard Garcia provided the Oath of Office to Maxfield Baker and Judge Maggie Moreno provided the Oath of Office to Saul Gonzales.

3. Consider nominations and appointments of the Mayor Pro Tem and optional Deputy Mayor Pro Tem.

Mayor Hughson opened the floor to nominations for the Mayor Pro Tem position.

Council Member Gonzales nominated Council Member Mihalkanin to serve as Mayor Pro Tem.

Council Member Marquez nominated Council Member Rockeymoore to serve as Mayor Pro Tem.

A roll call voice vote was taken on the nominations for Mayor Pro Tem as follows:

For Council Member Mihalkanin: Mayor Hughson, Council Member Derrick, Council Member Baker, Council Member Gonzales

For Council Member Rockeymoore: Council Member Marquez

Council Member Mihalkanin and Council Member Rockeymoore both abstained.

Mayor Hughson opened the floor to nominations for the Deputy Mayor Pro Tem position.

Council Member Mihalkanin nominated Council Member Rockeymoore to serve as Deputy Mayor Pro Tem, seconded by Council Member Gonzales. The nomination was unanimously approved by the following vote:
