




Figure 112: SMFD 8-Minute Effective Response Force
Six fire stations with Station 2 relocated to Centerpoint, and Station 6 at Old Bastrop west of Posey with minimum staffing of 20 personnel.



Notice of Public Hearing Zoning Change Request "SC" Smart Code District to "CD-5" Character District 5 North Side of Centerpoint Rd. Between Old Bastrop Hwy & Centerpoint Ct. / Gas Lamp Zone Change (SC to CD-5)

ZC-22-13 (North Side of Centerpoint Rd. Between Old Bastrop Hwy & Centerpoint Ct. / Gas Lamp Zone Change / SC to CD-5) Hold a public hearing and consider a request by David Carroll, on behalf of Walton Texas, LP, for a Zoning Change from Smart Code (SC) to Character District 5 (CD-5), or, subject to consent of the owner, another less intense zoning district classification, for approximately 48.87 acres generally located on the north side of Centerpoint Rd. between Old Bastrop Hwy and Centerpoint Ct. (W. Rugeley)

The San Marcos Planning and Zoning Commission will consider the above request at an upcoming public hearing to obtain citizen comments and will recommend approval, or denial of the request.
