Consider approval of Resolution 2022-263R, approving a contract with The Pounds Group, LLC DBA Sullivan Contracting Services through the Choice Partners Purchasing Cooperative for airport hangars repairs at the San Marcos Regional Airport for the Public Works Department in the estimated amount of \$95,671.83; authorizing the City Manager or her designee to execute the contract on behalf of the City; and declaring an effective date.
- 2. Consider approval of Resolution 2022-264R, awarding and approving a contract with Atlas Environmental, Inc. for Aquatic Invasive Fish & Snail Removal in the estimated annual amount of \$16,200.00, plus up to four one-year extensions for a total estimated contract amount of \$81,000.00; authorizing the City Manager or her designee, to execute the contract on behalf of the City; and declaring an effective date.

- 3. Consider approval of Resolution 2022-265R, awarding and approving a contract with EBR Enterprises for Removal of Invasive Plants from the Riparian Buffer of the San Marcos River in the estimated annual amount of \$38,412.50, plus up to four one-year extensions for a total estimated contract amount of \$192,062.50; authorizing the City Manager or her designee to execute the contract on behalf of the City; and declaring an effective date.
- 4. Consider approval of Resolution 2022-266R, authorizing Change in Service No. 3 to the contract with Schneider Engineering, LLC for Engineering Services for regulatory tracking and compliance that provides for a one year extension of the contract, plus administratively approved one year extensions for a term up to six years in the estimated annual amount of \$18,000.00 and estimated cumulative amount of \$102,000.00; authorizing the City Manager, or her designee, to execute the appropriate documents to implement the Change in Service on behalf of the City; and declaring an effective date.

Consider approval of Resolution 2022-267R, approving an interlocal agreement with the Lower Colorado River Authority (LCRA) for the provision of market support for the SMTXU Renewable Energy Credit Program; authorizing the City Manager or her designee to executive the agreement on behalf of the City; and declaring an effective date.
- **6.** Consider approval of Resolution 2022-268R, approving Change Orders #27 and #28 to the construction contract with Trimbuilt Construction, Inc. for Police Department Additions and Renovations increasing the contract amount by \$51,853.23 from \$9,886,410.19 to \$9,938,263.42; authorizing the City Manager, or her designee, to execute the appropriate documents relating to the Change Orders on behalf of the City; and declaring an effective date.
