- 4. The applicant shall maintain the existing landscaping screen along the boundary of the site;

- 5. The applicant shall provide 4 bicycle parking spaces in accordance with the minimum parking requirements set out in the Table 7.1 of the Land Development code
- 6. The permit shall be valid for one (1) year, provided standards are met;
- 7. The permit shall be effective only upon the issuance of a TABC License and a Certificate of Occupancy.
- 8. The permit shall be posted in the same area and manner as the Certificate of Occupancy, and
- 9. No outdoor amplified music shall be allowed.
