2. Be responsible for submission of a signed petition by 60 percent of all single family houses and four-flex or smaller rental properties located within the designated permit area.

The signed petition with required signatures is included as Attachment A.

3. Provide a description or map showing the proposed blocks of the designated permit area.

The proposed designated parking area includes all the 900 Block of Cheatham Street, the 900 Block of Field Street, the 900 Block of Sycamore Street, and the portion of the 800 block of Cheatham Street with residential units. There are no lots with addresses in the 800 block of Cheatham, but several residents including those on corner residential lots with frontage to 800 Cheatham noted frequent issues with parking and litter in this area, so it is requested that the portion of 800 Cheatham with residential lots be included in the designated permit area. A map outlining the proposed designated permit area is included as Attachment B.

4. Include the address of each residential lot within the proposed designated permit area.

A table including each address to be placed within the proposed designated permit area is included as Attachment C. While the portion of 800 Cheatham with residential lots is proposed to be included in the proposed designated permit area, there are no addresses on this block so there are none included in this list.

5. Identify any non-residential properties located within the proposed designated permit area, such as churches, schools, public facilities, or commercial establishments.

There is a single lot at 100 Roberts Street (Hays CAD ID: 136909) that appears to have a mixed use zoning. The rear portion of this lot has frontage onto Sycamore Street and the lot is currently vacant with no buildings or other structures. Roberts Street is not proposed to be included within the proposed designated permit area.

The corner lot at 413 Riverside Drive is used as a commercial business with a food truck and has side frontage on 800 Cheatham Street. The proposed designated permit area only includes the portion of the 800 Block of Cheatham with residential lots, so this commercial establishment is not included within the proposed designated permit area.

6. Provide a statement of the proposed parking restrictions desired by the applicants, including days of the week, times of the day, and the length of time for the parking restriction.

The desired restrictions are for the residential parking to be in effect at all times. This would include all hours of the day, every day of the week, and every month of the year. 
