FY 2021-22 Tax Rate

September 7, 2021



- M&O Rate: Adopted rate for maintenance & operations
- I&S (Debt) Rate: Adopted rate for eligible debt
- Total Tax Rate: Adopted M&O plus I&S tax rates
- No New Revenue Rate (prev. Effective): tax rate that would produce the same amount of taxes if applied to the same properties taxed in both years
- Voter Approval Rate (prev. Rollback): maximum rate allowed by law without voter approval and is based on NNR M&O rate plus 3.5% plus the calculated I&S rate plus unused increment




FY22 Proposed Tax Rate 60.30 ¢

- The proposed tax rate of 60.30¢ is lower than both the no new revenue tax rate of 69.99¢ and the voter approval tax rate of 75.54¢.
- The proposed tax rate of 60.30¢ generates \$300K less revenue than the prior year on the same properties taxed in both years.
- New tax revenue generated from new properties on the tax roll amounts to \$1.4M.




San Marcos Tax Rates






San Marcos Tax Rate

FY22 General Fund 0.01¢ Increase

- 0.01 cent increase in tax rate = \$655K
- City Manager's Top Priorities for Our Growing Community
