Notification of Proposed Annexation by the City of San Marcos – AN-26-02 (Five Mile Dam Park Annexation)

Dear Public Entity Representative:

Under Local Government Code Chapter 43, cities are required to notify certain public entities of all proposed annexations. The San Marcos City Council is considering the following annexations that may affect your jurisdiction:

Annexation of 38.45 +/- acres of land out of the William Ward Survey, Abstract No. 467, in Hays County, Texas, generally located north of the Blanco River and west of the intersection of Post Road and Old Stagecoach Road.

All annexations are subject to notification, public hearings, and vote by City Council. The annexation schedule is as follows:

Ordinance 1st Reading (Public Hearing): April 21, 2026, at 6 p.m., City Council Chambers, City Hall, 630 E. Hopkins St, San Marcos. (This hearing is a hybrid of virtual and in-person meeting)

Ordinance 2nd Reading: May 5, 2026, at 6 p.m., City Council Chambers, City Hall, 630 E. Hopkins St, San Marcos. (Hybrid of virtual and in-person meeting)

The City Council of the City of San Marcos, Texas, will hold a public hearing via hybrid meeting at **6:00 p.m. on Tuesday, April 21, 2026**, to consider the above request.
