#### **Board Orientation**



Guidance for Application Review:

- The most impact on highest priority San Marcos needs
- Funding is competitive; no need to fund all
- All applicants considered equally
- Allocation based on scoring and discussion



Application evaluations are based on but not limited to the criteria stated in each section.

- 1. COMMUNITY NEED & JUSTIFICATION -15 POINTS
  - Documentation and justification of the need for the program in the City of San Marcos.



#### 2. IMPLEMENTATION -15 POINTS

- Resources are available and ready.
- Clearly defined objectives, measurable outcomes
- Past performance with HSAB funding

#### 3. IMPACT AND COST EFFECTIVENESS -15 POINTS

- impact on the identified need
- cost vs impact
- use of financial, staff, volunteer resources
- impact compared to other applicants



#### 4. COMMUNITY SUPPORT – 15 POINTS

- 3 letters of reference, residents and clients preferred
- Volunteers play a vital role
- Board members are actively involved

#### 5. COUNCIL PRIORITIES - 30 POINTS

- 10 points if 2 years serving San Marcos
- 10 points if office in San Marcos
- 10 points if this funding will create an increase in services or number of people served.



- 6. RISK 10 POINTS
- 5 points if >5 years' experience with a program of this size and complexity
- 5 points if 50% of funding is non-City
